# EMPLOYMENT APPEALS BOARD DECISION 2021-EAB-0736-R

Request for Reconsideration Dismissed

PROCEDURAL HISTORY: On March 10, 2021, the Oregon Employment Department (the Department) served notice of an administrative decision concluding that the employer discharged claimant for misconduct, disqualifying claimant from receiving unemployment insurance benefits effective February 21, 2021 (decision # 124457). Claimant filed a timely request for hearing. On June 11, 2021, ALJ Micheletti conducted a hearing, and on June 18, 2021 issued Order No. 21-UI-169030, reversing decision # 124457 by concluding that claimant's discharged was not for misconduct, and did not disqualify claimant from receiving benefits. On July 8, 2021, Order No. 21-UI-169030 became final without the employer having filed an application for review with the Employment Appeals Board (EAB). On September 7, 2021, the employer filed a late application for review with EAB. On October 1, 2021, EAB issued EAB Decision 2021-EAB-0736, dismissing the employer's application for review as late without a showing of good cause. On October 12, 2021, the employer filed a request for reconsideration of EAB Decision 2021-EAB-0736.

This decision is issued pursuant to EAB's authority under ORS 657.290(3).

**CONCLUSIONS AND REASONS:** The employer's request for reconsideration is dismissed.

ORS 657.290(3) authorizes the Employment Appeals Board to reconsider any previous decision of the Employment Appeals Board, including "the making of a new decision to the extent necessary and appropriate for the correction of previous error of fact or law." "Any party may request reconsideration to correct an error of material fact or law, or to explain any unexplained inconsistency with Employment Department rule, or officially stated Employment Department position, or prior Employment Department practice." OAR 471-041-0145(1) (May 13, 2019). The request is subject to dismissal unless it includes a statement that a copy was provided to the other parties, and is filed on or before the 20<sup>th</sup> day after the decision sought to be reconsidered was mailed. OAR 471-041-0145(2).

The employer's request for reconsideration did not include a statement or otherwise indicate that the employer provided a copy of the request for reconsideration to the claimant as required. The employer's request for reconsideration therefore is dismissed. Even if the employer's request for reconsideration

were allowed, however, EAB Decision 2021-EAB-0736 would be adhered to on reconsideration. EAB Decision 2021-EAB-0736 dismissed the employer's late application for review of Order No. 21-UI-169030 because the late application for review did not include a written statement describing the circumstances that prevented a timely filing, as required under OAR 471-041-0070(3). EAB Decision 2021-EAB-0736 did not err in dismissing the employer's late application for review on that basis, which was not inconsistent with Department rule, officially stated position, or prior practice.

**DECISION:** The request for reconsideration filed October 12, 2021 is dismissed. EAB Decision 2021-EAB-0736 and Order No. 21-UI-169030 remain undisturbed.
