

**EMPLOYMENT APPEALS BOARD DECISION**  
**2021-EAB-0757-R**

*Request for Reconsideration Allowed*  
*EAB Decision 2021-EAB-0757 Adhered to on Reconsideration*  
*Late Application for Review Dismissed*

**PROCEDURAL HISTORY AND FINDINGS OF FACT:** On November 10, 2020, the Oregon Employment Department (the Department) served notice of an administrative decision concluding that claimant received retirement pay in an amount greater than or equal to his weekly benefit amount and was disqualified from receiving unemployment insurance benefits during the weeks including April 5, 2020 through June 6, 2020 (weeks 15-20 through 23-20), and until the reason for the denial ended (decision # 93145). Claimant filed a timely request for hearing. On June 25, 2021, ALJ Janzen conducted a hearing, and on June 29, 2021 issued Order No. 21-UI-169538, affirming decision # 93145. On July 19, 2021, Order No. 21-UI-169538 became final without claimant having filed an application for review with the Employment Appeals Board (EAB). On September 17, 2021, claimant filed a late application for review with EAB. On October 8, 2021, EAB issued EAB Decision 2021-EAB-0757, dismissing claimant's late application for review without prejudice. On October 20, 2021, claimant filed a request for reconsideration with EAB.

This decision is issued pursuant to EAB's authority under ORS 657.290(3).

**CONCLUSIONS AND REASONS:** Claimant's request for reconsideration is allowed. EAB Decision 2021-EAB-0757 is adhered to on reconsideration.

ORS 657.290(3) authorizes the Employment Appeals Board to reconsider any previous decision of the Employment Appeals Board, including "the making of a new decision to the extent necessary and appropriate for the correction of previous error of fact or law." The request is subject to dismissal unless it includes a statement that a copy was provided to the other parties, and is filed on or before the 20<sup>th</sup> day after the decision sought to be reconsidered was mailed. OAR 471-041-0145(2) (May 13, 2019).

An application for review is timely if it is filed within 20 days of the date that the Office of Administrative Hearings (OAH) mailed the order for which review is sought. ORS 657.270(6); OAR 471-041-0070(1) (May 13, 2019). The 20-day filing period may be extended a "reasonable time" upon a showing of "good cause." ORS 657.875; OAR 471-041-0070(2). "Good cause" means that factors or

circumstances beyond the applicant's reasonable control prevented timely filing. OAR 471-041-0070(2)(a). A "reasonable time" is seven days after the circumstances that prevented the timely filing ceased to exist. OAR 471-041-0070(2)(b). A late application for review will be dismissed unless it includes a written statement describing the circumstances that prevented a timely filing. OAR 471-041-0070(3).

EAB dismissed claimant's late application for review without prejudice and subject to claimant filing a timely request for reconsideration within 20 days after EAB's dismissal decision was issued. Claimant filed a request for reconsideration consistent with the requirements set forth in OAR 471-041-0145. The request for reconsideration is, therefore, allowed.

However, 2021-EAB-0757, which dismissed claimant's late application for review without prejudice, is adhered to on reconsideration because claimant did not provide sufficient information in their reconsideration request to establish that they had good cause to file the late application for review. In a statement enclosed with their request, claimant stated that they "received no correspondence" after the hearing, that after four weeks they contacted their case worker who told claimant that "it had been mailed," and that they "requested another copy but it got to [claimant] after the date you requested." Claimant's Request for Reconsideration at 1. It appears from this statement that claimant never received the original copy of Order No. 21-UI-169538, and received a duplicate copy of it sometime later, after the order became final. If claimant did not receive a copy of the order under review until after it became final, claimant may have failed to file a timely application for review due to circumstances beyond their reasonable control. However, claimant did not specifically state when they received the copy of the order under review or otherwise became aware of it, or how much time passed between their receipt of the order under review and the date on which they filed their application for review, and therefore it is not clear whether claimant filed the application for review within a "reasonable time" of the date on which the circumstances that prevented the timely filing ceased to exist. Therefore, claimant did not show good cause for filing the late application for review.

**DECISION:** Claimant's request for reconsideration is allowed. On reconsideration, EAB Decision 2021-EAB-0757 is adhered to as clarified herein.
