# EMPLOYMENT APPEALS BOARD DECISION 2021-EAB-0763

Late Applications for Review Dismissed Without Prejudice

PROCEDURAL HISTORY AND FINDINGS OF FACT: On June 26, 2020, the Oregon Employment Department (the Department) served notice of an administrative decision concluding that the employer suspended claimant for misconduct connected with work, disqualifying claimant from receiving unemployment insurance benefits effective March 8, 2020 (decision #112052). On July 9, 2020, the Department served notice of an administrative decision, based in part on decision #112052, concluding that claimant willfully made a misrepresentation and failed to report a material fact to obtain unemployment insurance benefits, and assessing a \$1,208.00 overpayment of regular benefits, a \$4,800.00 overpayment of Federal Pandemic Unemployment Compensation (FPUC), a \$362.40 monetary penalty, and 12 penalty weeks. On July 16, 2020, decision #112052 became final without claimant having filed a request for hearing. On July 29, 2020, the July 9, 2020 overpayment decision became final without claimant having filed a request for hearing. On February 19, 2021, the Department served notice of an administrative decision concluding that claimant was not able to work from April 12, 2020 through April 18, 2020 (week 16-20) and was therefore not eligible to receive benefits for that week (decision #123207). On March 11, 2021, decision #123207 became final without claimant having filed a request for hearing.

On August 5, 2021, claimant filed late requests for hearing on decision # 112052, the July 9, 2020 overpayment decision, and decision # 123207. ALJ Kangas reviewed claimant's hearing requests, and on August 18, 2021, issued Orders No. 21-UI-172840, 21-UI-172837, and 21-UI-172818, dismissing claimant's requests for hearing on decision # 112052, the July 9, 2020 overpayment decision, and decision # 123207 as late, subject to claimant's right to renew the requests by responding to appellant questionnaires by September 1, 2021. On September 7, 2021, Orders No. 21-UI-172840, 21-UI-172837, and 21-UI-172818 became final without claimant having responded to the appellant questionnaires or filed applications for review of the orders with the Employment Appeals Board (EAB). On September

11, 2021, claimant filed late applications for review of Orders No. 21-UI-172840, 21-UI-172837, and 21-UI-172818 with EAB.

Pursuant to OAR 471-041-0095 (October 29, 2006), EAB consolidated its review of Orders No. 21-UI-172840, 21-UI-172837, and 21-UI-172818. For case-tracking purposes, this decision is being issued in triplicate (EAB Decisions 2021-EAB-0762, 2021-EAB-0763, and 2021-EAB-0761).

**CONCLUSIONS AND REASONS:** The applications for review are dismissed without prejudice.

On September 11, 2021, the appellant filed applications for review of Orders No. 21-UI-172840, 21-UI-172837, and 21-UI-172818 with the EAB. ORS 657.270(6) and ORS 657.270(7)(b) required the applications for review to be filed no later than September 7, 2021. The appellant's applications for review are therefore late, and these applications for review are dismissed.

The deadline for filing an application for review may be extended a reasonable time upon a showing of good cause. *See* ORS 657.875; OAR 471-041-0070 (May 13, 2019). If the appellant believes they have good cause and filed their late applications for review within a reasonable time, the appellant may request that EAB reconsider this decision under OAR 471-041-0145 (May 13, 2019).

EAB will dismiss any request for reconsideration that does not include all five of the following:

- 1. The appellant must file the request for reconsideration within 20 days of the date this decision was mailed; the date this decision was mailed is October 4, 2021, making the deadline October 25, 2021 to file the request for reconsideration, *and*
- 2. The appellant must include a statement on the request for reconsideration declaring that they sent a copy of the request to the other party, *and*
- 3. The appellant must provide additional specific details about the reason they filed a late application for review. For example, the appellant should include specific information about the date they received the ALJ's order, whether they read it, whether they agreed or disagreed with the ALJ's order, the reason(s) why they did not file the application for review before the deadline, whether they were experiencing a mental health condition and whether that condition prevented them from timely filing and if so how, whether they or their families were ill or quarantined around the deadline, whether they could not file a timely application for review for any other reason(s) not related to illness or quarantine, how that affected their ability to file a timely application for review, and any other specific details that might help EAB determine whether or not the appellant had "good cause," which means factors or circumstances beyond their reasonable control prevented them from filing a timely application for review, and
- 4. The appellant must provide the date the circumstances that prevented them from filing a timely application for review (which they listed in response to #3, above) ceased to exist, *and*
- 5. The appellant must provide sufficient information to prove that they filed their application for review within seven days of that date.

The appellant may file a request for reconsideration in many ways; please note that you need only file *one* request for reconsideration:

- 1. Use your smart phone, tablet, or computer to fill out the "File a Written Argument" form, available on EAB's website: https://www.oregon.gov/EMPLOY/EAB/Pages/default.aspx, or
- 2. Use your smart phone, tablet, or computer to send an email to EAB at OED\_EAB\_OFFICE@oregon.gov, *or*

- 4. Send EAB a fax at 503-378-2129.

**DECISION:** The applications for review filed September 11, 2021 are dismissed without prejudice. Orders No. 21-UI-172840, 21-UI-172837, and 21-UI-172818 remain undisturbed.
