

EMPLOYMENT APPEALS BOARD DECISION
2021-EAB-0777

Late Application for Review Allowed
Affirmed – No Disqualification

PROCEDURAL HISTORY: On July 15, 2021, the Oregon Employment Department (the Department) served notice of an administrative decision concluding that the employer discharged claimant for misconduct, disqualifying claimant from receiving unemployment insurance effective May 23, 2021 (decision # 72509). Claimant filed a timely request for hearing. On August 31, 2021, ALJ Mott conducted a hearing, and on September 1, 2021 issued Order No. 21-UI-173770, reversing decision # 72509 by concluding that claimant's discharge was not for misconduct, and did not disqualify claimant from receiving unemployment insurance benefits. On September 21, 2021, Order No. 21-UI-173770 became final without the employer having filed an application for review with the Employment Appeals Board (EAB). On September 28, 2021, the employer filed a late application for review with EAB.

LATE APPLICATION FOR REVIEW: An application for review is timely if it is filed within 20 days of the date that the Office of Administrative Hearings (OAH) mailed the order for which review is sought. ORS 657.270(6); OAR 471-041-0070(1) (May 13, 2019). The 20-day filing period may be extended a "reasonable time" upon a showing of "good cause." ORS 657.875; OAR 471-041-0070(2). "Good cause" means that factors or circumstances beyond the applicant's reasonable control prevented timely filing. OAR 471-041-0070(2)(a). A "reasonable time" is seven days after the circumstances that prevented the timely filing ceased to exist. OAR 471-041-0070(2)(b). A late application for review will be dismissed unless it includes a written statement describing the circumstances that prevented a timely filing. OAR 471-041-0070(3).

In a statement included with their late application for review, the employer explained that they did not receive the order under review until September 22, 2021—one day after the filing deadline had passed. The employer's failure to receive the order under review until September 22, 2021 constituted a circumstance beyond the employer's reasonable control that prevented a timely filing. Because the employer filed their late application for review six days after they received the order under review, which is a reasonable time under OAR 471-041-0070(2)(b), the employer's late application for review is allowed.

WRITTEN ARGUMENT: Claimant's argument contained information that was not part of the hearing record, and did not show that factors or circumstances beyond claimant's reasonable control prevented them from offering the information during the hearing. Under ORS 657.275(2) and OAR 471-041-0090 (May 13, 2019), EAB considered only information received into evidence at the hearing when reaching this decision. EAB considered claimant's argument to the extent it was based on the record.

EAB reviewed the entire hearing record. On *de novo* review and pursuant to ORS 657.275(2), the order under review is **adopted**.

DECISION: Order No. 21-UI-173770 is affirmed.
