

EMPLOYMENT APPEALS BOARD DECISION
2021-EAB-0780

Affirmed
No Disqualification

PROCEDURAL HISTORY: On December 23, 2020, the Oregon Employment Department (the Department) served notice of an administrative decision concluding that the employer discharged claimant, not for misconduct, which did not disqualify claimant from receiving unemployment insurance benefits (decision # 133540). The employer filed a timely request for hearing. On August 25 and September 9, 2021, ALJ Frank conducted a hearing, and on September 20, 2021 issued Order No. 21-UI-175166, affirming decision # 133540. On September 23, 2021, the employer filed an application for review with the Employment Appeals Board (EAB).

WRITTEN ARGUMENT: In his written argument, claimant requested that EAB consider additional evidence under OAR 471-041-0090 (May 13, 2019), asserting that the ALJ erred in excluding testimony and other evidence that claimant had offered into the hearing record. OAR 471-041-0090 states, in relevant part, that EAB may receive additional evidence into the record if necessary to complete the record, and that EAB may allow a party's request for EAB to consider additional evidence when the party offering the additional evidence establishes that the additional evidence is relevant and material to EAB's determination. OAR 471-040-0025(5) states, in relevant part, that "erroneous rulings on evidence shall not preclude the administrative law judge from entering a decision unless shown to have substantially prejudiced the rights of a party."

Claimant's additional evidence was not material to EAB's determination, and therefore is not necessary to complete the record. Thus, to the extent, if any, the ALJ erred in excluding the evidence, the erroneous rulings did not prejudice claimant's rights, and were harmless. Claimant's request for EAB to consider additional evidence therefore is denied. EAB considered only information received into evidence at the hearing when reaching this decision. EAB considered claimant's argument to the extent it was based on the record.

EAB reviewed the entire hearing record. On *de novo* review and pursuant to ORS 657.275(2), the order under review is **adopted**.

DECISION: Order No. 21-UI-175166 is affirmed.
