# EMPLOYMENT APPEALS BOARD DECISION 2021-EAB-0788-R

Request for Reconsideration Allowed EAB Decision 2021-EAB-0788 Adhered to On Reconsideration Disqualification

**PROCEDURAL HISTORY:** On December 23, 2020, the Oregon Employment Department (the Department) served notice of an administrative decision concluding that the employer discharged claimant not for misconduct within 15 days of claimant's planned voluntary quit without good cause, disqualifying claimant from receiving unemployment insurance benefits effective March 22, 2020 (decision #131731). Claimant filed a timely request for hearing. On August 31, 2021, ALJ Lucas conducted a hearing, and on September 2, 2021 issued Order No. 21-UI-173939, affirming decision #131731. On September 14, 2021, claimant filed an application for review with the Employment Appeals Board (EAB). On October 20, 2021, EAB issued EAB Decision 2021-EAB-0788, affirming order No. 21-UI-173939 by concluding that claimant quit working for the employer without good cause, disqualifying claimant from receiving benefits effective March 22, 2020.

On October 22, 2021, after EAB issued EAB Decision 2021-EAB-0788, EAB received from claimant a timely filed written argument, which EAB construed as a timely request for reconsideration of EAB Decision 2021-EAB-0788. This decision is issued pursuant to EAB's authority under ORS 657.290(3).

**CONCLUSIONS AND REASONS:** Claimant's request for reconsideration is allowed. EAB Decision 2021-EAB-0788 is adhered to on reconsideration.

ORS 657.290(3) authorizes EAB to reconsider any previous decision of the Employment Appeals Board, including "the making of a new decision to the extent necessary and appropriate for the correction of previous error of fact or law." "Any party may request reconsideration to correct an error of material fact or law, or to explain any unexplained inconsistency with Employment Department rule, or officially stated Employment Department position, or prior Employment Department practice." OAR 471-041-0145(1) (May 13, 2019).

Claimant filed a timely written argument. EAB's decision to issue EAB Decision 2021-EAB-0788 before the written argument due date was in error. Claimant's request for reconsideration is, therefore, allowed.

However, claimant's written argument contained new information about the impact that the COVID-19 pandemic had on claimant's plans after claimant quit working for the employer that he did not make part of the hearing record in the case. Although EAB may consider a party's new information under limited circumstances, claimant failed to show that factors or circumstances beyond his reasonable control prevented him from offering the information during the hearing, as required under ORS 657.275(2) and OAR 471-041-0090 (May 13, 2019). EAB therefore did not consider claimant's new information, and considered his arguments only to the extent they were based upon information that had already been received into evidence at the hearing when reaching this decision.

For the reasons explained in EAB Decision 2021-EAB-0788, and having reconsidered that decision in light of claimant's written arguments, claimant did not establish that he quit working for the employer with good cause. Claimant therefore is disqualified from receiving benefits effective March 22, 2020.

**DECISION:** Claimant's request for reconsideration is allowed. On reconsideration, EAB Decision 2021-EAB-0788 is adhered to as clarified herein.
