EMPLOYMENT APPEALS BOARD DECISION 2021-EAB-0789

Late Application for Review Dismissed

PROCEDURAL HISTORY: On July 31, 2020, the Oregon Employment Department (the Department) served notice of an administrative decision concluding that claimant was paid unemployment insurance benefits to which they were not entitled and assessing a combined overpayment of \$1,248 in regular benefits and Federal Pandemic Unemployment Compensation benefits that claimant was required to repay to the Department (decision #80650). On August 20, 2020, decision #80650 became final without claimant having filed a request for hearing. On March 22, 2021, claimant filed a late request for hearing on decision #80650. ALJ Kangas considered claimant's request, and on April 21, 2021, issued Order No. 21-UI-165277, dismissing claimant's request as late, subject to claimant's right to renew the request by responding to an appellant questionnaire by May 5, 2021. On May 11, 2021, Order No. 21-UI-165277 became final without claimant having filed a response to the appellant questionnaire, or an application for review with the Employment Appeals Board (EAB). On September 28, 2021, claimant filed a late application for review of Order No. 21-UI-165277 with EAB.

FINDING OF FACT: (1) Order No. 21-UI-165277, mailed to claimant on April 21, 2021, stated, "You may appeal this decision by filing the attached form Application for Review with the Employment Appeals Board within 20 days of the date that this decision is mailed." Order No. 21-UI-165277 at 2. Order No. 21-UI-165277 also stated on its Certificate of Mailing, "Any party may appeal this Order by filing a Request for Review with the Employment Appeals Board no later than May 11, 2021."

CONCLUSIONS AND REASONS: Claimant's late application for review of Order No. 21-UI-165277 is dismissed.

An application for review is timely if it is filed within 20 days of the date that the Office of Administrative Hearings (OAH) mailed the order for which review is sought. ORS 657.270(6); OAR 471-041-0070(1) (May 13, 2019). The 20-day filing period may be extended a "reasonable time" upon a showing of "good cause." ORS 657.875; OAR 471-041-0070(2). "Good cause" means that factors or circumstances beyond the applicant's reasonable control prevented timely filing. OAR 471-041-0070(2)(a). A "reasonable time" is seven days after the circumstances that prevented the timely filing ceased to exist. OAR 471-041-0070(2)(b). A late application for review will be dismissed unless it

includes a written statement describing the circumstances that prevented a timely filing. OAR 471-041-0070(3).

The application for review of Order No. 21-UI-165277 was due by May 11, 2021. Because claimant did not file their application for review until September 28, 2021, the application for review was late. Claimant provided a written statement with the application for review. However, claimant's written statement did not describe the circumstances that prevented claimant from filing the application for review on time. Accordingly, claimant did not show good cause for the late application for review, and claimant's late application for review is dismissed.

DECISION: The application for review filed September 28, 2021 is dismissed. Order No. 21-UI-165277 remains undisturbed.
