# EMPLOYMENT APPEALS BOARD DECISION 2021-EAB-0799

Late Application for Review Dismissed

PROCEDURAL HISTORY: On June 22, 2021, the Oregon Employment Department (the Department) served notice of an administrative decision concluding that claimant was discharged not for misconduct within fifteen days of claimant's planned quit without good cause, and was disqualified from receiving unemployment insurance benefits effective June 6, 2021 based on the work separation (decision # 111608). On July 12, 2021, decision # 111608 became final without claimant having filed a request for hearing. On July 14, 2021, claimant filed a late request for hearing on decision # 111608. ALJ Kangas considered claimant's late request for hearing, and on July 21, 2021, issued Order No. 21-UI-170767, dismissing claimant's request for hearing on decision # 111608 as late, subject to claimant's right to renew the request by responding to an appellant questionnaire by August 4, 2021. On August 10, 2021, Order No. 21-UI-170767 became final without claimant having responded to the appellant questionnaire or filed an application for review with the Employment Appeals Board (EAB). On October 3, 2021, claimant filed a late application for review of Order No. 21-UI-170767 with EAB.

**FINDING OF FACT:** (1) Order No. 21-UI-170767, mailed to claimant on July 21, 2021, stated, "You may appeal this decision by filing the attached form Application for Review with the Employment Appeals Board within 20 days of the date that this decision is mailed." Order No. 21-UI-170767 at 2. Order No. 21-UI-170767 also stated on its Certificate of Mailing, "Any party may appeal this Order by filing a Request for Review with the Employment Appeals Board no later than August 10, 2021."

**CONCLUSIONS AND REASONS:** Claimant's late application for review of Order No. 21-UI-170767 is dismissed.

An application for review is timely if it is filed within 20 days of the date that the Office of Administrative Hearings (OAH) mailed the order for which review is sought. ORS 657.270(6); OAR 471-041-0070(1) (May 13, 2019). The 20-day filing period may be extended a "reasonable time" upon a showing of "good cause." ORS 657.875; OAR 471-041-0070(2). "Good cause" means that factors or circumstances beyond the applicant's reasonable control prevented timely filing. OAR 471-041-0070(2)(a). A "reasonable time" is seven days after the circumstances that prevented the timely filing ceased to exist. OAR 471-041-0070(2)(b). A late application for review will be dismissed unless it

includes a written statement describing the circumstances that prevented a timely filing. OAR 471-041-0070(3).

The application for review of Order No. 21-UI-170767 was due by August 10, 2021. Because claimant did not file their application for review until October 3, 2021, the application for review was late. Claimant provided a written statement with the application for review. Claimant stated on their application for review that they were a person without housing, the order under review was sent to their mailing address, and that they "just received" the order because they were not aware that it had been sent to their mailing address. Claimant also stated that they have post-traumatic stress disorder, anxiety and depression that makes it difficult for them to remain employed.

Claimant's written statement did not describe how lacking housing, but having a mailing address, was a circumstance that prevented them from filing the application for review on time. Nor did claimant's written statement explain why their mental health conditions prevented them from filing the application for review by August 10, 2021. Claimant asserted that they were not aware that Order No. 21-UI-170767 had been sent to their mailing address. However, claimant apparently requested a hearing regarding the denial of their unemployment insurance benefits, and it was foreseeable that the Department or Office of Administrative Hearings would mail claimant information regarding that request at claimant's mailing address. Claimant's statement did not describe circumstances that prevented a timely filing. Accordingly, claimant did not show good cause for the late application for review, and claimant's late application for review is dismissed.

**DECISION:** The application for review filed October 3, 2021 is dismissed. Order No. 21-UI-170767 remains undisturbed.
