EMPLOYMENT APPEALS BOARD DECISION 2021-EAB-0800

Late Application for Review Dismissed

PROCEDURAL HISTORY: On July 6, 2021, the Oregon Employment Department (the Department) served notice of an administrative decision concluding that claimant failed to register following the rules set by the Director and was denied benefits beginning June 13, 2021 until the reason for the denial had ended. On July 26, 2021, the July 6, 2021 administrative decision became final without claimant having filed a request for hearing. On August 5, 2021, claimant filed a late request for hearing on the July 6, 2021 administrative decision. ALJ Kangas considered claimant's late request for hearing, and on August 23, 2021, issued Order No. 21-UI-173133, dismissing claimant's request for hearing on the July 6, 2021 administrative decision as late, subject to claimant's right to renew the request by responding to an appellant questionnaire by September 6, 2021. On September 13, 2021, Order No. 21-UI-173133 became final without claimant having responded to the appellant questionnaire or filed an application for review with the Employment Appeals Board (EAB).

On September 17, 2021 claimant filed a late response to the appellant questionnaire and a late application for review with EAB. On September 22, 2021, ALJ Kangas mailed a letter to claimant stating that because their response to the appellant questionnaire was late, the Office of Administrative Hearings (OAH) would not consider it or issue another order regarding claimant's late request for hearing and that Order No. 21-UI-173133 remained in effect. This matter comes before EAB based upon claimant's September 17, 2021 late application for review of Order No. 21-UI-173133.

FINDING OF FACT: (1) Order No. 21-UI-173133, mailed to claimant on August 23, 2021, stated, "You may appeal this decision by filing the attached form Application for Review with the Employment Appeals Board within 20 days of the date that this decision is mailed." Order No. 21-UI-173133 at 2. Order No. 21-UI-173133 also stated on its Certificate of Mailing, "Any party may appeal this Order by filing a Request for Review with the Employment Appeals Board no later than September 13, 2021."

CONCLUSIONS AND REASONS: Claimant's late application for review of Order No. 21-UI-173133 is dismissed.

An application for review is timely if it is filed within 20 days of the date that the Office of Administrative Hearings (OAH) mailed the order for which review is sought. ORS 657.270(6); OAR

471-041-0070(1) (May 13, 2019). The 20-day filing period may be extended a "reasonable time" upon a showing of "good cause." ORS 657.875; OAR 471-041-0070(2). "Good cause" means that factors or circumstances beyond the applicant's reasonable control prevented timely filing. OAR 471-041-0070(2)(a). A "reasonable time" is seven days after the circumstances that prevented the timely filing ceased to exist. OAR 471-041-0070(2)(b). A late application for review will be dismissed unless it includes a written statement describing the circumstances that prevented a timely filing. OAR 471-041-0070(3).

The application for review of Order No. 21-UI-173133 was due by September 13, 2021. Because claimant did not file their application for review until September 17, 2021, the application for review was late. Claimant provided a written statement with the application for review. However, claimant's written statement did not describe the circumstances that prevented them from filing the application for review on time. Accordingly, claimant did not show good cause for the late application for review, and claimant's late application for review is dismissed.

DECISION: The application for review filed September 17, 2021 is dismissed. Order No. 21-UI-173133 remains undisturbed.
