

EMPLOYMENT APPEALS BOARD DECISION
2021-EAB-0804

Affirmed
Ineligible Weeks 29-21 through 31-21

PROCEDURAL HISTORY: On August 10, 2021, the Oregon Employment Department (the Department) served notice of an administrative decision concluding that claimant had failed to register for work in accordance with the Department's rules and therefore was ineligible to receive unemployment insurance benefits for the week of July 18, 2021 through July 24, 2021 (week 29-21) and until the reason for the denial had ended. Claimant filed a timely request for hearing. On September 20, 2021, ALJ Logan conducted a hearing, and on September 23, 2021 issued Order No. 21-UI-175513, modifying the August 10, 2021 administrative decision by concluding that claimant had failed to register for work in accordance with the Department's rules, and therefore was ineligible for benefits, for the weeks including July 18, 2021 through August 7, 2021 (weeks 29-21 through 31-21). On October 1, 2021, claimant filed an application for review with the Employment Appeals Board (EAB).

EAB reviewed the entire hearing record. On *de novo* review and pursuant to ORS 657.275(2), the order under review is **adopted**.

DECISION: Order No. 21-UI-175513 is affirmed.
