EMPLOYMENT APPEALS BOARD DECISION
2021-EAB-0820-R

*Request for Reconsideration Dismissed
EAB Decision 2021-EAB-0820 and Order No. 21-UI-175005 Remain Undisturbed*

PROCEDURAL HISTORY AND FINDINGS OF FACT: On August 17, 2021, the Oregon Employment Department (the Department) served notice of an administrative decision concluding that claimant voluntarily quit work without good cause and was disqualified from receiving unemployment insurance benefits effective July 18, 2021 (decision # 82435). Claimant filed a timely request for hearing. On September 16, 2021, ALJ Messecar conducted a hearing, and on September 17, 2021 issued Order No. 21-UI-175005, affirming decision # 82435. On October 7, 2021, Order No. 21-UI-175005 became final without claimant having filed an application for review the Employment Appeals Board (EAB). On October 11, 2021, claimant filed a late application for review with EAB. On November 1, 2021, EAB issued EAB Decision 2021-EAB-0820, dismissing claimant's late application for review without prejudice. On November 1, 2021, claimant filed a timely request for reconsideration of EAB Decision 2021-EAB-0820. This decision is issued pursuant to EAB's authority under ORS 657.290(3).

CONCLUSIONS AND REASONS: Claimant's request for reconsideration of EAB Decision 2021-EAB-0820 is dismissed.

ORS 657.290(3) authorizes the Employment Appeals Board (EAB) to reconsider any previous decision of EAB, including "the making of a new decision to the extent necessary and appropriate for the correction of previous error of fact or law." "Any party may request reconsideration to correct an error of material fact or law, or to explain any unexplained inconsistency with Employment Department rule, or officially stated Employment Department position, or prior Employment Department practice." OAR 471-041-0145(1) (May 13, 2019). The request is subject to dismissal unless it includes a statement that a copy was provided to the other parties, and is filed on or before the 20th day after the decision sought to be reconsidered was mailed. OAR 471-041-0145(2).

On November 1, 2021, claimant filed a request for reconsideration of EAB Decision 2021-EAB-0820 with EAB, which was timely because it was filed before the 20th day after the decision sought to be reconsidered was mailed. However, claimant's request for reconsideration did not include a statement or otherwise indicate that claimant provided a copy of the request for reconsideration to the employer. The

reconsideration request is therefore dismissed for failure to serve a copy of the request for reconsideration on the other party.

DECISION: The request for reconsideration filed November 1, 2021 is dismissed. Employment Appeals Board Decision 2021-EAB-0820 and Order No. 21-UI-175005 remain undisturbed.
