

**EMPLOYMENT APPEALS BOARD DECISION**  
**2021-EAB-0825**

*Affirmed*  
*Late Request for Hearing Dismissed*

**PROCEDURAL HISTORY:** On February 14, 2019, the Oregon Employment Department (the Department) served notice of an administrative decision concluding that claimant received benefits they were not entitled to receive and assessing an overpayment of \$3,619 that claimant was liable to have deducted from future benefits otherwise payable to claimant (decision # 142318). On March 6, 2019, decision # 142318 became final without claimant having filed a request for hearing. On May 30, 2021, claimant filed a late request for hearing. ALJ Kangas considered claimant's request, and on July 1, 2021 issued Order No. 21-UI-169669, dismissing the request as late, subject to claimant's right to renew the request by responding to an appellant questionnaire by July 15, 2021. On July 13, 2021, claimant filed a timely response to the appellant questionnaire. ALJ S. Lee considered claimant's response, and on October 4, 2021 issued Order No. 21-UI-176254, cancelling Order No. 21-UI-169669, re-dismissing claimant's late request for hearing, and leaving decision # 142318 undisturbed. On October 13, 2021, claimant filed an application for review of Order No. 21-UI-176254 with the Employment Appeals Board (EAB).

**WRITTEN ARGUMENT:** EAB considered claimant's written argument when reaching this decision.

EAB reviewed the entire hearing record. On *de novo* review and pursuant to ORS 657.275(2), the order under review is **adopted**.

**DECISION:** Order No. 21-UI-176254 is affirmed.
