EMPLOYMENT APPEALS BOARD DECISION 2021-EAB-0829

Late Application for Review Allowed
Affirmed ~ Disqualification

PROCEDURAL HISTORY: On April 5, 2021, the Oregon Employment Department (the Department) served notice of an administrative decision concluding that claimant voluntarily quit work without good cause and was disqualified from receiving unemployment insurance benefits effective November 22, 2020 (decision #81234). Claimant filed a timely request for hearing. On May 12, 2021, ALJ Schmidt conducted a hearing at which the employer failed to appear, and on May 14, 2021 issued Order No. 21-UI-166806, affirming decision #81234. On June 3, 2021, Order No. 21-UI-166806 became final without claimant having filed a timely application for review with the Employment Appeals Board (EAB). On October 15, 2021, claimant filed a late application for review of Order No. 21-UI-166806 with EAB.

LATE APPLICATION FOR REVIEW: An application for review is timely if it is filed within 20 days of the date that the Office of Administrative Hearings (OAH) mailed the order for which review is sought. ORS 657.270(6); OAR 471-041-0070(1) (May 13, 2019). The 20-day filing period may be extended a "reasonable time" upon a showing of "good cause." ORS 657.875; OAR 471-041-0070(2). "Good cause" means that factors or circumstances beyond the applicant's reasonable control prevented timely filing. OAR 471-041-0070(2)(a). A "reasonable time" is seven days after the circumstances that prevented the timely filing ceased to exist. OAR 471-041-0070(2)(b). A late application for review will be dismissed unless it includes a written statement describing the circumstances that prevented a timely filing. OAR 471-041-0070(3).

An application for review of Order No. 21-UI-166806 was due by June 3, 2021. Because claimant filed an application for review on October 15, 2021, the application for review was late. In her late application for review, claimant included a written statement describing the circumstances that prevented a timely filing. The application for review stated that claimant called the Department on May 28, 2021 to request a "second appeal" and was told she had done so and that she should wait for someone to contact her about the appeal. After waiting a period of time for a response, claimant subsequently called EAB and was told to complete the application for review on a form she should send to EAB. Claimant sent EAB the application for review at that time. The apparent delay in the Department processing claimant's application for review constituted a circumstance beyond claimant's

reasonable control that prevented a timely filing. Because claimant filed her late application for review when they were told to do so by EAB, ending the circumstance that cause the late filing, claimant filed their application for review in a reasonable time under OAR 471-041-0070(2)(b). For these reasons, claimant's late application for review is allowed.

WRITTEN ARGUMENT: EAB did not consider claimant's written argument when reaching this decision on the merits of decision #81234 because she did not include a statement declaring that she provided a copy of her argument to the opposing party or parties as required by OAR 471-041-0080(2)(a) (May 13, 2019).

EAB reviewed the entire hearing record. On *de novo* review and pursuant to ORS 657.275(2), the order under review is **adopted**.

DECISION: Order No. 21-UI-166806 is affirmed.
