

EMPLOYMENT APPEALS BOARD DECISION
2021-EAB-0831

Late Application for Review Dismissed

PROCEDURAL HISTORY: On July 15, 2021, the Oregon Employment Department (the Department) served a Notice of Determination for Pandemic Unemployment Assistance (PUA) concluding that claimant was not entitled to receive PUA benefits effective February 2, 2020. On August 4, 2021, the PUA determination became final without claimant having filed a request for hearing. On August 8, 2021, claimant filed a late request for hearing. ALJ Kangas considered claimant's hearing request, and on September 14, 2021 issued Order No. 21-UI-174707, dismissing claimant's request for hearing as late, subject to claimant's right to renew the request by responding to an appellant questionnaire by September 28, 2021. On October 4, 2021, Order No. 21-UI-174707 became final without claimant having filed a response to the appellant questionnaire or an application for review with the Employment Appeals Board (EAB). On October 14, 2021, claimant filed a late application for review of Order No. 21-UI-174707 with EAB.

FINDING OF FACT: (1) Order No. 21-UI-174707, mailed to claimant on September 14, 2021, stated, "You may appeal this decision by filing the attached form Application for Review with the Employment Appeals Board within 20 days of the date that this decision is mailed." Order No. 21-UI-174707 at 2. Order No. 21-UI-174707 also stated on its Certificate of Mailing, "Any party may appeal this Order by filing a Request for Review with the Employment Appeals Board no later than October 4, 2021."

CONCLUSIONS AND REASONS: Claimant's late application for review of Order No. 21-UI-174707 is dismissed.

An application for review is timely if it is filed within 20 days of the date that the Office of Administrative Hearings (OAH) mailed the order for which review is sought. ORS 657.270(6); OAR 471-041-0070(1) (May 13, 2019). The 20-day filing period may be extended a "reasonable time" upon a showing of "good cause." ORS 657.875; OAR 471-041-0070(2). "Good cause" means that factors or circumstances beyond the applicant's reasonable control prevented timely filing. OAR 471-041-0070(2)(a). A "reasonable time" is seven days after the circumstances that prevented the timely filing ceased to exist. OAR 471-041-0070(2)(b). A late application for review will be dismissed unless it includes a written statement describing the circumstances that prevented a timely filing. OAR 471-041-0070(3).

The application for review of Order No. 21-UI-174707 was due October 4, 2021. Because claimant did not file their application for review until October 14, 2021, the application for review was late. The application for review stated that the circumstances that had prevented claimant from filing the application for review on time ceased to exist on August 26, 2021. However, Order No. 21-UI-174707 was not issued until September 14, 2021. Claimant failed to describe any circumstances that prevented claimant from filing the application for review of Order No. 21-UI-174707 by the October 4, 2021 deadline. Accordingly, claimant did not show good cause for the late application for review, and the late application for review is dismissed.

DECISION: The application for review filed October 14, 2021 is dismissed. Order No. 21-UI-174707 remains undisturbed.
