

EMPLOYMENT APPEALS BOARD DECISION
2021-EAB-0833

Affirmed
Request for Hearing Allowed
No Disqualification

PROCEDURAL HISTORY: On February 10, 2021, the Oregon Employment Department (the Department) served notice of an administrative decision concluding that the employer discharged claimant for misconduct, disqualifying claimant from receiving unemployment insurance benefits effective December 6, 2020 (decision # 94021). On March 2, 2021, decision # 94021 became final without claimant having filed a request for hearing. On March 29, 2021, claimant filed a late request for hearing. ALJ Kangas considered claimant's request, and on April 21, 2021 issued Order No. 21-UI-165211, dismissing the request as late, subject to claimant's right to renew the request by responding to an appellant questionnaire by May 5, 2021. On May 3, 2021, claimant filed a timely response to the appellant questionnaire. On July 12, 2021, the Office of Administrative Hearings (OAH) mailed a letter stating that Order No. 21-UI-165211 was vacated and that a new hearing would be scheduled to determine whether claimant's late request for hearing should be allowed and, if so, the merits of decision # 94021. On October 1, 2021, ALJ Janzen conducted a hearing, and on October 5, 2021 issued Order No. 21-UI-176349, allowing claimant's request for hearing as timely, and reversing decision # 94021 by concluding that claimant's discharge was not for misconduct, and did not disqualify claimant from receiving benefits. On October 12, 2021, the employer filed an application for review of Order No. 21-UI-176349 with the Employment Appeals Board (EAB).

WRITTEN ARGUMENT: The employer did not declare that they provided a copy of their argument to the opposing party or parties as required by OAR 471-041-0080(2)(a) (May 13, 2019). The argument also contained information that was not part of the hearing record, and did not show that factors or circumstances beyond the employer's reasonable control prevented them from offering the information during the hearing as required by OAR 471-041-0090 (May 13, 2019). EAB considered only information received into evidence at the hearing when reaching this decision. *See* ORS 657.275(2).

EAB reviewed the entire hearing record. On *de novo* review and pursuant to ORS 657.275(2), the order under review is **adopted**.

DECISION: Order No. 21-UI-176349 is affirmed.
