EMPLOYMENT APPEALS BOARD DECISION 2021-EAB-0839

Reversed No Disqualification

PROCEDURAL HISTORY: On June 23, 2021, the Oregon Employment Department (the Department) served notice of an administrative decision concluding that claimant was discharged for misconduct and was disqualified from receiving unemployment insurance benefits effective May 16, 2021 (decision # 144126). Claimant filed a timely request for hearing. On September 22, 2021, ALJ Lucas conducted a hearing, and on September 28, 2021 issued Order No. 21-UI-175819, affirming decision # 144126. On October 18, 2021, claimant filed an application for review with the Employment Appeals Board (EAB).

FINDINGS OF FACT: (1) Galaxy Wine Company employed claimant from July 1, 2018 until May 20, 2021.

- (2) The employer expected employees to refrain from yelling at others. Claimant generally was aware of and understood the employer's expectation.
- (3) In October 2020, the employer issued claimant a written warning for "insubordinate conduct, including swearing at his manager," on two occasions during that month. Transcript at 6. In February 2021, the employer issued claimant a final warning for "acting verbally aggressive[ly]" towards his manager." Transcript at 6.
- (4) On May 13, 2021, claimant was working on planning a large event for the employer, and felt both overwhelmed by the work and unsupported by management. That day, claimant had a phone call with his manager, who later reported that claimant was "yelling and antagonistic on the phone" with her. Transcript at 6.
- (5) On May 20, 2021, the employer discharged claimant due to his conduct on the phone call with his manager on May 13, 2021.

CONCLUSIONS AND REASONS: Claimant was discharged, but not for misconduct.

ORS 657.176(2)(a) requires a disqualification from unemployment insurance benefits if the employer discharged claimant for misconduct connected with work. "As used in ORS 657.176(2)(a) . . . a willful or wantonly negligent violation of the standards of behavior which an employer has the right to expect of an employee is misconduct. An act or series of actions that amount to a willful or wantonly negligent disregard of an employer's interest is misconduct." OAR 471-030-0038(3)(a) (September 22, 2020). "[W]antonly negligent' means indifference to the consequences of an act or series of actions, or a failure to act or a series of failures to act, where the individual acting or failing to act is conscious of his or her conduct and knew or should have known that his or her conduct would probably result in a violation of the standards of behavior which an employer has the right to expect of an employee." OAR 471-030-0038(1)(c). In a discharge case, the employer has the burden to establish misconduct by a preponderance of evidence. *Babcock v. Employment Division*, 25 Or App 661, 550 P2d 1233 (1976).

The order under review concluded that claimant's conduct on May 13, 2021 constituted misconduct because claimant had been aware of the employer's expectation that employees not yell at each other, and because he had already been warned about similar conduct previously. Order No. 21-UI-175819 at 3. The record does not support this conclusion.

At hearing, the employer's witness did not provide details on the May 13, 2021 incident other than to offer a description based on hearsay that claimant's conduct was "yelling and antagonistic." Claimant testified at hearing that he "was probably a little antagonistic" during the phone call with his manager on May 13, 2021. Transcript at 24. No further evidence was offered by either party at hearing to explain what claimant actually said to his manager during the phone call or the manner in which he said it. As it stands, the hearsay descriptions of claimant's conduct as being "antagonistic" or "yelling" are too subjective and too vague to gain an understanding of what actually transpired during the phone call. For that reason, the employer has not met their burden to show that claimant's conduct violated their standards of behavior. Therefore, claimant was discharged, but not for misconduct, and is not disqualified from receiving unemployment insurance benefits based on the work separation.

DECISION: Order No. 21-UI-175819 is set aside, as outlined above.
