

EMPLOYMENT APPEALS BOARD DECISION
2021-EAB-0840

Late Application for Review Dismissed Without Prejudice

PROCEDURAL HISTORY AND FINDINGS OF FACT: On May 26, 2021, the Oregon Employment Department (the Department) served notice of an administrative decision concluding that claimant filed late claims for unemployment insurance benefits for the weeks from February 28, 2021 through March 27, 2021 and was therefore denied benefits for those weeks (decision # 55725). On June 15, 2021, decision # 55725 became final without claimant having filed a request for hearing. On August 31, 2021, claimant filed a late request for hearing. ALJ Kangas reviewed claimant's request, and on September 7, 2021 issued Order No. 21-UI-174124, dismissing the request as late, subject to claimant's right to renew the request by responding to an appellant questionnaire by September 21, 2021. On September 27, 2021, Order No. 21-UI-174124 became final without claimant having filed a response to the appellant questionnaire or an application for review with the Employment Appeals Board (EAB). On October 18, 2021, claimant filed a late application for review of Order No. 21-UI-174124 with EAB.

CONCLUSIONS AND REASONS: The application for review is dismissed without prejudice.

On October 18, 2021, the appellant filed an application for review of Order No. 21-UI-174124 with the EAB. ORS 657.270(6) and ORS 657.270(7)(b) required the application for review to be filed no later than September 27, 2021. The appellant's application for review is therefore late, and this application for review is dismissed.

The deadline for filing an application for review may be extended a reasonable time upon a showing of good cause. See ORS 657.875; OAR 471-041-0070 (May 13, 2019). If the appellant believes they have good cause and filed their late application for review within a reasonable time, the appellant may request that EAB reconsider this decision under OAR 471-041-0145 (May 13, 2019).

EAB will dismiss any request for reconsideration that does not include **all five** of the following:

1. The appellant must file the request for reconsideration within 20 days of the date this decision was mailed; the date this decision was mailed is November 19, 2021, making the deadline December 9, 2021¹ to file the request for reconsideration, *and*
2. The appellant must include a statement on the request for reconsideration declaring that they sent a copy of the request to the other party, *and*
3. The appellant must provide additional specific details about the reason they filed a late application for review. For example, the appellant should include specific information about the date they received Order No. 21-UI-174124, whether they read it, whether they agreed or disagreed with Order No. 21-UI-174124, the reason(s) why they did not file the application for review before the deadline, how the reason(s) affected their ability to file a timely application for review, whether they or their families were ill (including mental illness) or quarantined around the deadline, whether they could not file a timely application for review for any other reason(s) not related to illness or quarantine (including moving to a different address), how that affected their ability to file a timely application for review, and any other specific details that might help EAB determine whether or not the appellant had “good cause,” which means factors or circumstances beyond their reasonable control prevented them from filing a timely application for review, *and*
4. The appellant must provide the date the circumstances that prevented them from filing a timely application for review (which they listed in response to #3, above) ceased to exist, *and*
5. The appellant must provide sufficient information to prove that they filed their application for review within seven days of that date.

The appellant may file a request for reconsideration in many ways; please note that you need only file *one* request for reconsideration:

1. Use your smart phone, tablet, or computer to fill out the “File a Written Argument” form, available on EAB’s website: <https://www.oregon.gov/EMPLOY/EAB/Pages/default.aspx>, *or*
2. Use your smart phone, tablet, or computer to send an email to EAB at OED_EAB_OFFICE@employ.oregon.gov, *or*
3. Send the request by U.S. mail or another delivery service, addressed to 875 Union St NE, Salem, Oregon 97311, *or*
4. Send EAB a fax at 503-378-2129.

DECISION: The application for review filed October 18, 2021 is dismissed without prejudice. Order No. 21-UI-174124 remains undisturbed.
