# EMPLOYMENT APPEALS BOARD DECISION 2021-EAB-0843

Late Application for Review Dismissed Disqualification

**PROCEDURAL HISTORY:** On May 25, 2021, the Oregon Employment Department (the Department) served notice of an administrative decision concluding that claimant quit working for the employer work without good cause and was disqualified from receiving unemployment insurance benefits effective December 27, 2020 (decision # 123158). Claimant filed a timely request for hearing. On September 20, 2021, ALJ Wardlow conducted a hearing at which the employer failed to appear, and on September 23, 2021 issued Order No. 21-UI-175505, affirming decision # 123158. On October 13, 2021, Order No. 21-UI-175505 became final without claimant having filed an application for review with the Employment Appeals Board (EAB). On October 14, 2021, the employer filed a late application for review with EAB.

**FINDING OF FACT:** (1) Order No. 21-UI-175505, mailed to the employer on September 23, 2021, stated, "You may appeal this decision by filing the attached form Application for Review with the Employment Appeals Board within 20 days of the date that this decision is mailed." Order No. 21-UI-175505 at 3. Order No. 21-UI-175505 also stated on its Certificate of Mailing, "Any appeal from this Order must be filed on or before October 13, 2021 to be timely."

**CONCLUSIONS AND REASONS:** The employer's late application for review of Order No. 21-UI-175505 is dismissed.

An application for review is timely if it is filed within 20 days of the date that the Office of Administrative Hearings (OAH) mailed the order for which review is sought. ORS 657.270(6); OAR 471-041-0070(1) (May 13, 2019). The 20-day filing period may be extended a "reasonable time" upon a showing of "good cause." ORS 657.875; OAR 471-041-0070(2). "Good cause" means that factors or circumstances beyond the applicant's reasonable control prevented timely filing. OAR 471-041-0070(2)(a). A "reasonable time" is seven days after the circumstances that prevented the timely filing ceased to exist. OAR 471-041-0070(2)(b). A late application for review will be dismissed unless it includes a written statement describing the circumstances that prevented a timely filing. OAR 471-041-0070(3).

The application for review of Order No. 21-UI-175505 was due by October 13, 2021. Because the employer did not file their application for review until October 14, 2021, the application for review was late. The employer's application for review did not include a written statement describing the circumstances that prevented them from filing the application for review by the October 13, 2021 deadline. Accordingly, the employer did not show good cause for the late application for review, and the employer's late application for review is dismissed.

The employer's application for review of Order No. 21-UI-175505 is also dismissed for the additional reason that it presents no justiciable controversy.

On October 14, 2021, EAB received from the employer an application for review of an order that denied claimant benefits. The employer did not assign error to any portion of that order, did not request reversal of any portion of the order, and alleged no facts entitling the employer to further relief in this matter. Accordingly, there is no justiciable controversy before EAB based upon the employer's application for review. *See accord Barcik v. Kubiacyk*, 321 Or 174, 895 P2d 765 (1995). Because the case before EAB presents no justiciable controversy, the application for review of Order No. 21-UI-175505 is dismissed and Order No. 21-UI-175505 remains undisturbed.

**DECISION:** The application for review filed October 14, 2021 is dismissed. Order No. 21-UI-175505 remains undisturbed.
