# EMPLOYMENT APPEALS BOARD DECISION 2021-EAB-0851-R

Late Request for Reconsideration Dismissed

PROCEDURAL HISTORY AND FINDINGS OF FACT: On December 17, 2020, the Oregon Employment Department (the Department) served a Notice of Determination for Pandemic Unemployment Assistance (PUA) concluding that claimant was not entitled to receive PUA benefits effective February 2, 2020. On January 6, 2021, the December 17, 2020 administrative decision became final without claimant having filed a request for hearing. On February 4, 2021, claimant filed a late request for hearing. ALJ Kangas considered claimant's request, and on March 1, 2021 issued Order No. 21-UI-161840, dismissing claimant's request for hearing as late, subject to claimant's right to renew the request by responding to an appellant questionnaire by March 15, 2021. On March 10, 2021, claimant filed a timely response to the appellant questionnaire. On April 20, 2021, the Office of Administrative Hearings (OAH) mailed a letter stating that Order No. 21-UI-161840 was vacated and that a hearing would be scheduled to consider whether claimant's late request for hearing should be allowed and, if so, the merits of the December 17, 2020 administrative decision. On September 22, 2021, ALJ Frank conducted a hearing, and on September 30, 2021 issued Order No. 21-UI-176085, re-dismissing claimant's request for hearing as late without good cause and leaving the December 17, 2020 administrative decision undisturbed. On October 20, 2021, claimant filed an application for review of Order No. 21-UI-176085 with the Employment Appeals Board (EAB).

On November 23, 2021, EAB issued EAB Decision 2021-EAB-0851, affirming Order No. 21-UI-176085. On December 23, 2021, claimant filed a late request for reconsideration of EAB Decision 2021-EAB-0851 with EAB. This decision is issued pursuant to EAB's authority under ORS 657.290(3).

**CONCLUSIONS AND REASONS:** Claimant's late request for reconsideration of EAB Decision 2021-EAB-0851 is dismissed.

ORS 657.290(3) authorizes EAB to reconsider any previous decision of EAB, including "the making of a new decision to the extent necessary and appropriate for the correction of previous error of fact or law." "Any party may request reconsideration to correct an error of material fact or law, or to explain any unexplained inconsistency with Employment Department rule, or officially stated Employment Department position, or prior Employment Department practice." OAR 471-041-0145(1) (May 13, 2019). The request is subject to dismissal unless it includes a statement that a copy was provided to the

other parties, and is filed on or before the 20th day after the decision sought to be reconsidered was mailed. OAR 471-041-0145(2).

EAB mailed EAB Decision 2021-EAB-0851 to claimant on November 23, 2021. Under OAR 471-041-0145(2), the request for reconsideration was due by December 13, 2021. Claimant's request for reconsideration was filed late, on December 23, 2021. OAR 471-041-0145(2) contains no exception to the requirement that a request for reconsideration be filed on or before the 20th day after the decision sought to be reconsidered was mailed. For this reason, claimant's request for reconsideration is dismissed.

**DECISION:** The request for reconsideration filed on November 23, 2021 is dismissed. Order No. 21-UI-176085 remains undisturbed.
