EMPLOYMENT APPEALS BOARD DECISION 2021-EAB-0856

Late Application for Review Dismissed Without Prejudice

FINDINGS OF FACT AND PROCEDURAL HISTORY: On December 31, 2020, the Oregon Employment Department (the Department) served a Notice of Determination for Pandemic Unemployment Assistance (PUA) concluding that claimant was not entitled to PUA benefits effective February 2, 2020. On January 20, 2021, the December 31, 2020 PUA determination became final without claimant having filed a request for hearing. On June 26, 2021, claimant filed a late request for hearing. ALJ Kangas considered claimant's request, and on August 5, 2021 issued Order No. 21-UI-171922, dismissing claimant's request for hearing as late, subject to claimant's right to renew the request by responding to an appellant questionnaire by August 19, 2021. On August 25, 2021, Order No. 21-UI-171922 became final without claimant having filed a response to the appellant questionnaire with the Office of Administrative Hearings (OAH) or an application for review of Order No. 21-UI-171922 with the Employment Appeals Board (EAB). On September 20, 2021, claimant filed a late response to the appellant questionnaire. On October 8, 2021, ALJ Kangas mailed a letter stating that OAH would not consider claimant's questionnaire response or issue another order regarding this matter because the questionnaire response was late. On October 19, 2021, claimant filed a late application for review with EAB.

CONCLUSIONS AND REASONS: The application for review is dismissed without prejudice.

On October 19, 2021, the appellant filed an application for review of Order No. 21-UI-171922 with the EAB. ORS 657.270(6) and ORS 657.270(7)(b) required the application for review to be filed no later than August 25, 2021. The appellant's application for review is therefore late, and this application for review is dismissed.

The deadline for filing an application for review may be extended a reasonable time upon a showing of good cause. *See* ORS 657.875; OAR 471-041-0070 (May 13, 2019). If the appellant believes they have good cause and filed their late application for review within a reasonable time, the appellant may request that EAB reconsider this decision under OAR 471-041-0145 (May 13, 2019).

EAB will dismiss any request for reconsideration that does not include **all five** of the following:

- 1. The appellant must file the request for reconsideration within 20 days of the date this decision was mailed; the date this decision was mailed is November 19, 2021, making the deadline December 9, 2021 to file the request for reconsideration, *and*
- 2. The appellant must include a statement on the request for reconsideration declaring that they sent a copy of the request to the other party, *and*
- 3. The appellant must provide additional specific details about the reason they filed a late application for review. For example, the appellant should include specific information about the date they received the ALJ's order, whether they read it, whether they agreed or disagreed with the ALJ's order, the reason(s) why they did not file the application for review before the deadline, how the reason(s) affected their ability to file a timely application for review, whether they or their families were ill or quarantined around the deadline, whether they could not file a timely application for review for any other reason(s) not related to illness or quarantine, how that affected their ability to file a timely application for review for any other reason(s) not related to illness or quarantine, how that affected their ability to file a timely application for review for any other reason(s) not related to illness or quarantine, how that might help EAB determine whether or not the appellant had "good cause," which means factors or circumstances beyond their reasonable control prevented them from filing a timely application for review, and
- 4. The appellant must provide the date the circumstances that prevented them from filing a timely application for review (which they listed in response to #3, above) ceased to exist, *and*
- 5. The appellant must provide sufficient information to prove that they filed their application for review within seven days of that date.

The appellant may file a request for reconsideration in many ways; please note that you need only file *one* request for reconsideration:

- 1. Use your smart phone, tablet, or computer to fill out the "File a Written Argument" form, available on EAB's website: https://www.oregon.gov/EMPLOY/EAB/Pages/default.aspx, or
- 2. Use your smart phone, tablet, or computer to send an email to EAB at OED_EAB_OFFICE@employ.oregon.gov, *or*

- 4. Send EAB a fax at 503-378-2129.

DECISION: The application for review filed October 19, 2021 is dismissed without prejudice. Order No. 21-UI-171922 remains undisturbed.
