

EMPLOYMENT APPEALS BOARD DECISION
2021-EAB-0857

Affirmed
Request for Hearing Dismissed

PROCEDURAL HISTORY AND FINDINGS OF FACT: On September 2, 2021, the Oregon Employment Department (the Department) served notice of an administrative decision concluding that claimant voluntarily quit work without good cause and was disqualified from receiving unemployment insurance benefits effective April 11, 2021 (decision # 121721). Claimant filed a timely request for hearing. On September 27, 2021, claimant filed a request to withdraw their request for a hearing on decision # 121721. ALJ Schmidt considered claimant's request and on October 1, 2021, issued Order No. 21-UI-176124, dismissing claimant's request for hearing based on claimant's request to withdraw their request for hearing and leaving decision # 121721 undisturbed. On October 21, 2021, claimant filed an application for review of Order No. 21-UI-176124 with the Employment Appeals Board (EAB).

EVIDENTIARY MATTER: The ALJ considered claimant's request to withdraw their request for hearing as a record document, but failed to mark it in the record. As a clerical matter, EAB identified claimant's request to withdraw their request for hearing in the record and marked it as a Record document.

FINDING OF FACT: (1) On September 27, 2021, claimant sent a communication to the Department via Web Form stating, "I just got hired for a good paying job, in my field. I would like to withdraw my appeal, as I won't be needing the assistance of unemployment insurance." Record.

CONCLUSIONS AND REASONS: Claimant's request for hearing is dismissed.

ORS 657.270(7)(a)(A) provides that the administrative law judge may dismiss a request for hearing if the request is withdrawn by the requesting party. OAR 471-040-0035(1) (August 1, 2004) also provides that an administrative law judge may order that a request for hearing be dismissed upon request from the appellant to withdraw the request for hearing.

On September 27 2021, claimant, the appellant, filed a request to withdraw their request for hearing. The administrative law judge granted claimant's request and dismissed claimant's request for hearing

pursuant to ORS 657.270(7)(a)(A) and OAR 471-040-0035(1). Claimant's request for hearing on decision # 121721 is therefore dismissed.

DECISION: Order No. 21-UI-176124 is affirmed.
