

**EMPLOYMENT APPEALS BOARD DECISION**  
**2021-EAB-0865**

*Affirmed*  
*Late Request for Hearing Dismissed*

**PROCEDURAL HISTORY:** On April 6, 2021, the Oregon Employment Department (the Department) served notice of an administrative decision concluding that claimant received benefits to which they were not entitled, and assessing an overpayment of \$93 in regular unemployment insurance benefits and \$1,200 in Federal Pandemic Unemployment Compensation (FPUC) benefits that claimant was required to repay (decision # 131950). On April 26, 2021, decision # 131950 became final without claimant having filed a request for hearing. On June 15, 2021, claimant filed a late request for hearing. ALJ Kangas considered claimant's request, and on July 15, 2021 issued Order No. 21-UI-170387, dismissing the request as late, subject to claimant's right to renew the request by responding to an appellant questionnaire by July 29, 2021. On July 29, 2021, claimant filed a timely response to the appellant questionnaire. ALJ S. Lee reviewed claimant's response, and on October 5, 2021 issued Order No. 21-UI-176341, cancelling Order No. 21-UI-170387 and re-dismissing claimant's request for hearing as late without a showing of good cause, leaving decision # 131950 undisturbed. On October 22, 2021, claimant filed an application for review of Order No. 21-UI-176341 with the Employment Appeals Board (EAB).

EAB reviewed the entire hearing record. On *de novo* review and pursuant to ORS 657.275(2), the order under review is **adopted**.

**DECISION:** Order No. 21-UI-176341 is affirmed.
