EMPLOYMENT APPEALS BOARD DECISION 2021-EAB-0877

Affirmed Late Request for Hearing Dismissed

PROCEDURAL HISTORY: On May 26, 2021, the Oregon Employment Department (the Department) served notice of an administrative decision concluding that claimant received benefits to which they were not entitled, and assessing an overpayment of \$1,640 in Pandemic Unemployment Assistance (PUA) benefits and \$4,800 in Federal Pandemic Unemployment Compensation (FPUC) benefits that claimant was liable to repay to the Department (decision # 94825). On June 15, 2021, decision # 94825 became final without claimant having filed a request for hearing. On July 26, 2021, claimant filed a late request for hearing. ALJ Kangas considered claimant's request, and on August 4, 2021 issued Order No. 21-UI-171832, dismissing claimant's request for hearing as late, subject to claimant's right to renew the request by responding to an appellant questionnaire by August 18, 2021. UI-177135, canceling and replacing Order No. 21-UI-171832, dismissing claimant's request for hearing as late without good cause, and leaving decision # 94825 undisturbed. On October 25, 2021, claimant filed an application for review of Order No. 21-UI-177135 with the Employment Appeals Board (EAB).

WRITTEN ARGUMENT: Claimant's argument contained information that was not part of the record, and did not show that factors or circumstances beyond claimant's reasonable control prevented them from offering the information into the record. Under ORS 657.275(2) and OAR 471-041-0090 (May 13, 2019), EAB considered only information received into the record when reaching this decision. EAB considered claimant's argument to the extent it was based on the record.

FINDINGS OF FACT: (1) On May 26, 2021, the Department mailed decision # 94825 to claimant's address on file with the Department. Claimant did not receive decision # 94825.

(2) On July 9, 2021, claimant received a billing statement from the Department. Shortly thereafter, claimant called the Department and spoke to a Department representative who advised claimant to make a request for hearing on decision #94825.

(3) On July 26, 2021, claimant made a request for hearing on decision # 94825.

CONCLUSIONS AND REASONS: Claimant's late request for hearing is dismissed.

ORS 657.269 provides that the Department's decisions become final unless a party files a request for hearing within 20 days after the date the decision is mailed. ORS 657.875 provides that the 20-day deadline may be extended a "reasonable time" upon a showing of "good cause." OAR 471-040-0010 (February 10, 2012) provides that "good cause" includes factors beyond an applicant's reasonable control or an excusable mistake, and defines "reasonable time" as seven days after those factors ceased to exist.

The request for hearing on decision # 94825 was due by June 15, 2021. Because claimant did not file their request for hearing until July 26, 2021, the request was late. Claimant established good cause to extend the June 15, 2021 deadline to file their request for hearing. This is because claimant's failure to file their request for hearing arose from their failure to receive decision # 94825, which was a factor beyond claimant's reasonable control that prevented claimant from filing. However, on July 9, 2021, this factor beyond claimant's reasonable control ceased to exist when claimant called the Department and spoke to a representative who advised claimant of their right to appeal and to make a request for hearing. The deadline to file a request for hearing was therefore extended to July 16, 2021, which is the sevenday "reasonable time" from July 9, 2021 when the factor that prevented a timely filing ceased to exist. Claimant filed their request for hearing on July 26, 2021, after the seven-day "reasonable time" period concluded. Accordingly, claimant did not file their late request for hearing within a reasonable time, and claimant's late request for hearing on decision # 94825 is subject to dismissal under ORS 657.875 and OAR 471-040-0010.

DECISION: Order No. 21-UI-177135 is affirmed.
