

EMPLOYMENT APPEALS BOARD DECISION
2021-EAB-0885

Affirmed
No Claim Redetermination

PROCEDURAL HISTORY: On September 10, 2021, the Oregon Employment Department (the Department) served notice of a wage and potential benefit report dated September 9, 2021 concluding that claimant's claim for unemployment insurance benefits was monetarily nonvalid because he had not earned sufficient wages since the beginning date of his previous unemployment insurance claim. Claimant filed a timely request for hearing. On October 11, 2021, ALJ Frank conducted a hearing, and on October 13, 2021 issued Order No. 21-UI-177036, affirming the September 9, 2021 administrative decision. On October 29, 2021, claimant filed an application for review with the Employment Appeals Board (EAB).

WRITTEN ARGUMENT: EAB considered claimant's written argument when reaching this decision. In his argument, claimant suggested that the "double-dip" provision of ORS 657.150(2)(a)(B), which was the basis for the Department's conclusion that claimant did not have a valid claim, "may have been overlooked during the alternation [sic] of the Department's regular 'normal' governing laws." Claimant's Written Argument at 1. However, claimant did not cite to any authority which modified the requirements of ORS 657.150(2)(a)(B) during the period of time at issue in this matter, and EAB is aware of none. Claimant also explained that he was unable to earn any wages subsequent to his separation from his base-year employer in August 2020 because he was a member of a closed union that did not permit members to seek non-union work within the trade. Claimant's Written Argument at 1. Because ORS 657.150(2)(a)(B) contains no good-cause exceptions to the "double-dip" requirement, the requirement applies to claimant regardless of the reason for his lack of wages after August 2020.

EAB reviewed the entire hearing record. On *de novo* review and pursuant to ORS 657.275(2), the order under review is **adopted**.

DECISION: Order No. 21-UI-177036 is affirmed.
