

EMPLOYMENT APPEALS BOARD DECISION
2021-EAB-0887

Reversed & Remanded

PROCEDURAL HISTORY AND FINDINGS OF FACT: On July 6, 2021, the Oregon Employment Department (the Department) served notice of an administrative decision concluding that claimant failed to register for work in accordance with the Department's rules and therefore was ineligible to receive unemployment insurance benefits for the week of June 13, 2021 through June 19, 2021 (week 24-21) and until the reason for the denial had ended. On July 26, 2021, the July 6, 2021 administrative decision became final without claimant having filed a request for hearing. On August 3, 2021, claimant filed a late request for hearing on the July 6, 2021 administrative decision.

ALJ Kangas considered claimant's request, and on September 24, 2021 issued Order No. 21-UI-175529, dismissing the request as late, subject to claimant's right to renew the request by responding to an appellant questionnaire by October 8, 2021. On October 14, 2021, claimant filed a late response to the appellant questionnaire and a timely application for review of Order No. 21-UI-175529 with the Employment Appeals Board (EAB). On November 1, 2021, ALJ Kangas mailed a letter stating that the Office of Administrative Hearings (OAH) would not consider claimant's questionnaire response or issue another order regarding this matter because the questionnaire response was late. This matter comes before EAB based upon claimant's October 14, 2021 application for review of Order No. 21-UI-175529.

EVIDENTIARY MATTER: EAB has considered additional evidence when reaching this decision under OAR 471-041-0090(1) (May 13, 2019). The additional evidence is claimant's response to the appellant questionnaire and a statement attached thereto, marked as EAB Exhibit 1, and a copy provided to the parties with this decision. Any party that objects to our admitting EAB Exhibit 1 must submit such objection to this office in writing, setting forth the basis of the objection in writing, within ten days of our mailing this decision. OAR 471-041-0090(2). Unless such objection is received and sustained, the exhibit(s) will remain in the record.

CONCLUSIONS AND REASONS: Order No. 21-UI-175529 is set aside and this matter remanded for a hearing on whether claimant's late request for hearing on the July 6, 2021 administrative decision should be allowed and, if so, the merits of that decision.

ORS 657.269 provides that the Department's decisions become final unless a party files a request for hearing within 20 days after the date the decision is mailed. ORS 657.875 provides that the 20-day deadline may be extended a "reasonable time" upon a showing of "good cause." OAR 471-040-0010 (February 10, 2012) provides that "good cause" includes factors beyond an applicant's reasonable control or an excusable mistake, and defines "reasonable time" as seven days after those factors ceased to exist.

Claimant's request for hearing on the July 6, 2021 administrative decision was due by July 26, 2021. Because claimant did not file their request for hearing until August 3, 2021, the request for hearing was late. In the statement attached to the appellant questionnaire response, claimant indicated that they "did not receive a notice that [they] needed to file an appeal or instructions on how to file an appeal until 7/30/21" when they contacted the Department, and that they "have not been receiving letters." EAB Exhibit 1 at 3. Claimant also indicated that they subsequently filed requests for hearing on the July 6, 2021 administrative decision twice: first, "through the unemployment website" on July 30, 2021, and second by telephone with the help of a Department representative on August 3, 2021. EAB Exhibit 1 at 3.

If claimant never received a copy of the July 6, 2021 administrative decision prior to learning of the denial of benefits on July 30, 2021, claimant may have filed the request for hearing late due to factors beyond their reasonable control. However, further inquiry is needed to determine whether claimant's statement that they "ha[d] not been receiving letters" meant that they were not receiving any of their mail, that they were not receiving mailed correspondence from the Department, that they received the July 6, 2021 administrative decision but did not understand the appeals procedure, or other circumstances. On remand, the record should be developed to determine what issues claimant was experiencing with their mail delivery and for what period of time; when, if at all, claimant received a copy of the July 6, 2021 administrative decision; why claimant did not file a request for hearing prior to July 30, 2021; and whether claimant filed the request within a reasonable time once the factors that prevented them from filing a timely request for hearing ceased.

Order No. 21-UI-175529 therefore is reversed, and this matter remanded for a hearing on whether claimant's late request for hearing should be allowed and, if so, the merits of the July 6, 2021 administrative decision.

DECISION: Order No. 21-UI-175529 is set aside, and this matter remanded for further proceedings consistent with this order.
