

EMPLOYMENT APPEALS BOARD DECISION
2021-EAB-0901

Affirmed
Late Request for Hearing Dismissed

PROCEDURAL HISTORY: On March 8, 2021, the Oregon Employment Department (the Department) served notice of an administrative decision concluding that claimant willfully made a misrepresentation and failed to report a material fact to obtain unemployment insurance benefits, and assessing a \$13,318 overpayment of regular benefits, a \$2,100 overpayment of Federal Pandemic Unemployment Compensation (FPUC), a \$3,995.40 monetary penalty, and 52 penalty weeks. On March 29, 2021, the March 8, 2021 administrative decision became final without claimant having filed a request for hearing. On May 12, 2021, claimant filed a late request for hearing. ALJ Kangas considered claimant's request, and on May 26, 2021, issued Order No. 21-UI-167521, dismissing the request as late, subject to claimant's right to renew the request by responding to an appellant questionnaire by June 9, 2021. On June 1 and June 7, 2021, claimant filed timely responses to the appellant questionnaire. On August 9, 2021, the Office of Administrative Hearings (OAH) mailed claimant a letter stating that Order No. 21-UI-167521 was vacated and a hearing would be scheduled to address the timeliness of claimant's hearing request and, if appropriate, the merits of the March 8, 2021 administrative decision. On October 18, 2021, ALJ Monroe conducted a hearing at which the employer failed to appear, and on October 26, 2021 issued Order No. 21-UI-178170, dismissing claimant's request for hearing as late without good cause, leaving the March 8, 2021 administrative decision undisturbed. On November 1, 2021, claimant filed an application for review with the Employment Appeals Board (EAB).

WRITTEN ARGUMENT: Claimant submitted written argument on November 10, 2021 and November 22, 2021. Claimant's argument contained information that was not part of the hearing record, and did not show that factors or circumstances beyond claimant's reasonable control prevented her from offering the information during the hearing. Under ORS 657.275(2) and OAR 471-041-0090 (May 13, 2019), EAB considered only information received into evidence at the hearing when reaching this decision. EAB considered claimant's argument to the extent it was based on the record.

EAB reviewed the entire hearing record. On *de novo* review and pursuant to ORS 657.275(2), the order under review is **adopted**.

DECISION: Order No. 21-UI-178170 is affirmed.
