EMPLOYMENT APPEALS BOARD DECISION 2021-EAB-0905

Application for Review Dismissed

PROCEDURAL HISTORY: On August 25, 2021, the Oregon Employment Department (the Department) served notice of an administrative decision concluding that claimant voluntarily quit work without good cause and was disqualified from receiving unemployment insurance benefits effective May 9, 2021 (decision # 115802). Claimant filed a timely request for hearing. On October 6, 2021, ALJ Janzen conducted a hearing, and on October 7, 2021 issued Order No. 21-UI-176568, affirming decision # 115802. On October 27, 2021, Order No. 21-UI-176568 became final without claimant having filed an application for review with the Employment Appeals Board (EAB). On October 28, 2021, claimant filed a late application for review of Order No. 21-UI-176568 with EAB.

WRITTEN ARGUMENT: EAB did not consider claimant's written argument when reaching this decision because he did not include a statement declaring that he provided a copy of his argument to the opposing party or parties as required by OAR 471-041-0080(2)(a) (May 13, 2019).

FINDING OF FACT: (1) Order No. 21-UI-176568, mailed to claimant on October 7, 2021, stated, "You may appeal this decision by filing the attached form Application for Review with the Employment Appeals Board within 20 days of the date that this decision is mailed." Order No. 21-UI-176568 at 3. Order No. 21-UI-176568 also stated on its Certificate of Mailing, "Any appeal from this Order must be filed on or before October 27, 2021 to be timely."

CONCLUSIONS AND REASONS: Claimant's late application for review of Order No. 21-UI-176568 is dismissed.

An application for review is timely if it is filed within 20 days of the date that the Office of Administrative Hearings (OAH) mailed the order for which review is sought. ORS 657.270(6); OAR 471-041-0070(1) (May 13, 2019). The 20-day filing period may be extended a "reasonable time" upon a showing of "good cause." ORS 657.875; OAR 471-041-0070(2). "Good cause" means that factors or circumstances beyond the applicant's reasonable control prevented timely filing. OAR 471-041-0070(2)(a). A "reasonable time" is seven days after the circumstances that prevented the timely filing ceased to exist. OAR 471-041-0070(2)(b). A late application for review will be dismissed unless it

includes a written statement describing the circumstances that prevented a timely filing. OAR 471-041-0070(3).

The application for review of Order No. 21-UI-176568 was due October 27, 2021. Because claimant did not file their application for review until October 28, 2021, the application for review was late. Claimant provided a written statement with the application for review. However, claimant's written statement did not describe the circumstances that prevented claimant from filing the application for review on time and cannot be considered because it did not include a statement declaring that he provided a copy of his argument to the opposing party or parties as required by OAR 471-041-0080(2)(a) (May 13, 2019). Accordingly, claimant did not show good cause for the late application for review, and claimant's late application for review is dismissed.

DECISION: The application for review filed October 28, 2021 is dismissed. Order No. 21-UI-176568 remains undisturbed.
