

EMPLOYMENT APPEALS BOARD DECISION
2021-EAB-0908

Affirmed
Late Request for Hearing Dismissed

PROCEDURAL HISTORY AND FINDINGS OF FACT: On June 22, 2021, the Oregon Employment Department (the Department) served notice of an administrative decision concluding that claimant was overpaid \$686 in Pandemic Emergency Unemployment Compensation (PEUC) benefits that they must repay the Department (decision # 113044). On July 12, 2021, decision # 113044 became final without claimant having filed a request for hearing. On July 16, 2021, claimant filed a late request for hearing. ALJ Kangas considered claimant's request, and on August 2, 2021 issued Order No. 21-UI-171603, dismissing the request as late, subject to claimant's right to renew the request by responding to an appellant questionnaire by August 16, 2021. On August 13, 2021, claimant filed a timely response to the appellant questionnaire. ALJ S. Lee considered claimant's response to the appellant questionnaire, and on October 22, 2021 issued Order No. 21-UI-177873, canceling Order No. 21-UI-171603 and re-dismissing claimant's late request for hearing as without good cause, leaving decision # 113044 undisturbed. On October 28, 2021, claimant filed an application for review of Order No. 21-UI-172499 with the Employment Appeals Board (EAB).

WRITTEN ARGUMENT: Claimant's argument contained information that was not part of the hearing record, and did not show that factors or circumstances beyond claimant's reasonable control prevented them from offering the information into the hearing record in their response to the appellant questionnaire. Under ORS 657.275(2) and OAR 471-041-0090 (May 13, 2019), EAB considered only information received into the hearing record when reaching this decision.

EAB reviewed the entire hearing record. On *de novo* review and pursuant to ORS 657.275(2), the order under review is **adopted**.

DECISION: Order No. 21-UI-177873 is affirmed.
