

EMPLOYMENT APPEALS BOARD DECISION
2021-EAB-0917

Application for Review Dismissed

PROCEDURAL HISTORY: : On July 15, 2021, the Oregon Employment Department (the Department) served notice of an administrative decision concluding that claimant was denied benefits for the weeks including March 28, 2021 through May 22, 2021 (weeks 13-21 through 20-21) because he made late weekly claims for benefits for those weeks (decision # 93648). Claimant filed a timely request for hearing. On October 7, 2021, ALJ Logan conducted a hearing and issued Order No. 21-UI-176655, affirming decision # 93648. On October 27, 2021, Order No. 21-UI-176655 became final without claimant having filed an application for review with the Employment Appeals Board (EAB). On November 1, 2021, claimant filed a late application for review of Order No. 21-UI-176655 with EAB.

FINDING OF FACT: (1) Order No. 21-UI-176655, mailed to claimant on October 7, 2021, stated, “You may appeal this decision by filing the attached form Application for Review with the Employment Appeals Board within 20 days of the date that this decision is mailed.” Order No. 21-UI-176655 at 3. Order No. 21-UI-176655 also stated on its Certificate of Mailing, “Any appeal from this Order must be filed on or before October 27, 2021 to be timely.”

CONCLUSIONS AND REASONS: Claimant’s late application for review of Order No. 21-UI-176655 is dismissed.

An application for review is timely if it is filed within 20 days of the date that the Office of Administrative Hearings (OAH) mailed the order for which review is sought. ORS 657.270(6); OAR 471-041-0070(1) (May 13, 2019). The 20-day filing period may be extended a “reasonable time” upon a showing of “good cause.” ORS 657.875; OAR 471-041-0070(2). “Good cause” means that factors or circumstances beyond the applicant’s reasonable control prevented timely filing. OAR 471-041-0070(2)(a). A “reasonable time” is seven days after the circumstances that prevented the timely filing ceased to exist. OAR 471-041-0070(2)(b). A late application for review will be dismissed unless it includes a written statement describing the circumstances that prevented a timely filing. OAR 471-041-0070(3).

The application for review of Order No. 21-UI-176655 was due October 27, 2021. Because claimant did not file their application for review until November 1, 2021, the application for review was late.

Claimant's application for review did not include a written statement describing the circumstances that prevented him from filing the application for review by the October 27, 2021 deadline. Accordingly, claimant did not show good cause for the late application for review, and claimant's late application for review is dismissed.

DECISION: The application for review filed November 1, 2021 is dismissed. Order No. 21-UI-176655 remains undisturbed.
