

**EMPLOYMENT APPEALS BOARD DECISION**  
**2021-EAB-0918**

*Affirmed*  
*Late Request for Hearing Dismissed*

**PROCEDURAL HISTORY:** On September 29, 2017, the Oregon Employment Department (the Department) served notice of an administrative decision concluding that claimant willfully made a misrepresentation and failed to report a material fact to obtain unemployment insurance benefits, and assessing a \$3,540 overpayment of regular unemployment insurance benefits that claimant was required to repay to the Department, a \$531 monetary penalty, and 24 penalty weeks (decision # 193647). On October 19, 2017, decision # 193647 became final without claimant having filed a request for hearing. On July 16, 2021, claimant filed a late request for hearing on decision # 193647. ALJ Kangas considered claimant's request, and on August 2, 2021 issued Order No. 21-UI-171569, dismissing claimant's request as late, subject to claimant's right to renew the request by responding to an appellant questionnaire by August 16, 2021. On August 10, 2021, claimant filed a timely response to the appellant questionnaire. ALJ Kangas considered claimant's response to the appellant questionnaire, and on October 14, 2021 issued Order No. 21-UI-177158, canceling Order No. 21-UI-171569, redissmissing claimant's request for hearing as late without a showing of good cause, and leaving decision # 193647 undisturbed. On November 3, 2021, claimant filed an application for review of Order No. 21-UI-177158 with the Employment Appeals Board (EAB).

EAB reviewed the entire hearing record. On *de novo* review and pursuant to ORS 657.275(2), the order under review is **adopted**.

**DECISION:** Order No. 21-UI-177158 is affirmed.
