

EMPLOYMENT APPEALS BOARD DECISION
2021-EAB-0924

Reversed & Remanded

PROCEDURAL HISTORY AND FINDINGS OF FACT: On July 06, 2021, the Oregon Employment Department (the Department) served notice of an administrative decision concluding claimant was not eligible for unemployment insurance benefits beginning June 13, 2021 and until the reason for the denial ended because claimant failed to register for work in accordance with the Department's regulations. On July 26, 2021, the July 6, 2021 decision became final without claimant having filed a request for hearing. On August 13, 2021, claimant filed a late request for hearing. On August 30, 2021, ALJ Kangas issued Order No. 21-UI-173631, dismissing claimant's request for hearing as late without a showing of good cause, subject to claimant's right to renew their request by filing a response to an appellant questionnaire within 14 days. On September 16, 2021, claimant filed a late response to the appellant questionnaire, and a timely application for review of Order No. 21-UI-173631 with the Employment Appeals Board (EAB). On September 22, 2021, ALJ Kangas issued a letter stating that because claimant's response to the appellant questionnaire was filed late, it would not be considered, another order would not be issued, and Order No. 21-UI-173631 would remain in effect.

EVIDENTIARY MATTER: EAB has considered additional evidence when reaching this decision under OAR 471-041-0090(1) (May 13, 2019). The additional evidence is claimant's response to the appellant questionnaire, and has been marked as EAB Exhibit 1, and a copy provided to the parties with this decision. Any party that objects to our admitting EAB Exhibit 1 must submit such objection to this office in writing, setting forth the basis of the objection in writing, within ten days of our mailing this decision. OAR 471-041-0090(2). Unless such objection is received and sustained, the exhibit(s) will remain in the record.

CONCLUSIONS AND REASONS: Order No. 21-UI-173631 is set aside and this matter remanded for a hearing on whether claimant's late request for hearing should be allowed, and if so, the merits of the decision issued on July 06, 2021.

ORS 657.269 provides that the Department's decisions become final unless a party files a request for hearing within 20 days after the date the decision is mailed. ORS 657.875 provides that the 20-day deadline may be extended a "reasonable time" upon a showing of "good cause." OAR 471-040-0010 (February 10, 2012) provides that "good cause" includes factors beyond an applicant's reasonable

control or an excusable mistake, and defines “reasonable time” as seven days after those factors ceased to exist. A letter duly directed and mailed was received in the regular course of the mail. ORS 40.135(1)(q).

The deadline to file a timely request for hearing on the July 6, 2021 decision was July 26, 2021. Claimant filed their request for hearing on August 13, 2021. Therefore, the request for hearing was late. Claimant’s response to the appellant questionnaire suggests that they might have had good cause for filing a late request for hearing due to factors beyond their reasonable control and/or an excusable mistake. In their response to the appellant questionnaire, claimant stated that they did not receive the July 6, 2021 decision until August 12, 2021, because they lost their housing “during the time that this decision was made.” EAB Exhibit 1 at 1. However, further inquiry is needed into whether claimant provided the Department with their updated address or whether claimant made arrangements to pick-up their mail from their previous address and if so with which frequency.

Order No. 21-UI-173631 therefore is reversed and this matter remanded for a hearing on whether claimant’s late request for hearing on the July 6, 2021 decision should be allowed and, if so, the merits of that decision.

DECISION: Order No. 21-UI-173631 is set aside, and this matter remanded for further proceedings consistent with this order.
