EMPLOYMENT APPEALS BOARD DECISION 2021-EAB-0925

Late Application for Review Dismissed

PROCEDURAL HISTORY: On July 9, 2021, the Oregon Employment Department (the Department) served notice of an administrative decision concluding that claimant filed late claims for unemployment insurance benefits for the weeks from December 6, 2020 through January 2, 2021 (weeks 50-20 through 53-20) and therefore was not eligible to receive benefits for those weeks (decision #61157). On July 29, 2021, decision #61157 became final without claimant having filed a request for hearing. On August 5, 2021, claimant filed a late request for hearing. ALJ Kangas considered claimant's request, and on August 13, 2021 issued Order No. 21-UI-172563, dismissing claimant's request for hearing as late, subject to claimant's right to renew the request by responding to an appellant questionnaire by August 27, 2021. On September 2, 2021, Order No. 21-UI-172563 became final without claimant having filed a response to the appellant questionnaire or an application for review with the Employment Appeals Board (EAB). On September 24, 2021, claimant filed a late response to the appellant questionnaire. On October 11, 2021, ALJ S. Lee mailed a letter to claimant stating that because claimant's response to the questionnaire was late, the office of Administrative Hearings (OAH) would not consider it or issue another order, and that Order No. 21-UI-172563 remained in effect. On October 22, 2021, claimant filed a late application for review of Order No. 21-UI-172563 with EAB.

FINDING OF FACT: (1) Order No. 21-UI-172563, mailed to claimant on August 13, 2021, stated, "You may appeal this decision by filing the attached form Application for Review with the Employment Appeals Board within 20 days of the date that this decision is mailed." Order No. 21-UI-172563 at 2. Order No. 21-UI-172563 also stated on its Certificate of Mailing, "Any party may appeal this Order by filing a Request for Review with the Employment Appeals Board no later than September 2, 2021."

CONCLUSIONS AND REASONS: Claimant's late application for review of Order No. 21-UI-172563 is dismissed.

An application for review is timely if it is filed within 20 days of the date that OAH mailed the order for which review is sought. ORS 657.270(6); OAR 471-041-0070(1) (May 13, 2019). The 20-day filing period may be extended a "reasonable time" upon a showing of "good cause." ORS 657.875; OAR 471-041-0070(2). "Good cause" means that factors or circumstances beyond the applicant's reasonable control prevented timely filing. OAR 471-041-0070(2)(a). A "reasonable time" is seven days after the

circumstances that prevented the timely filing ceased to exist. OAR 471-041-0070(2)(b). A late application for review will be dismissed unless it includes a written statement describing the circumstances that prevented a timely filing. OAR 471-041-0070(3).

The application for review of Order No. 21-UI-172563 was due September 2, 2021. Because claimant did not file their application for review until October 22, 2021, the application for review was late. Claimant provided a written statement with the application for review. However, claimant's written statement did not describe the circumstances that prevented claimant from filing the application for review on time. Accordingly, claimant did not show good cause for the late application for review, and claimant's late application for review is dismissed.

DECISION: The application for review filed October 22, 2021 is dismissed. Order No. 21-UI-172563 remains undisturbed.
