

**EMPLOYMENT APPEALS BOARD DECISION**  
**2021-EAB-0927**

*Late Application for Review Dismissed*

**PROCEDURAL HISTORY:** On January 20, 2021, the Oregon Employment Department (the Department) served notice of an administrative decision concluding that claimant quit working for the employer without good cause and was disqualified from receiving unemployment insurance benefits effective June 30, 2019 (decision # 110825). Claimant filed a timely request for hearing. On August 12, 2021, ALJ Lucas conducted a hearing at which the employer failed to appear, and on August 18, 2021, issued Order No. 21-UI-172895, affirming decision # 110825. On September 7, 2021, Order No. 21-UI-172895 became final without claimant having filed an application for review with the Employment Appeals Board (EAB). On November 5, 2021, claimant filed a late application for review of Order No. 21-UI-172895 with EAB.

**FINDING OF FACT:** (1) Order No. No. 21-UI-172895, mailed to claimant on August 18, 2021, stated, “You may appeal this decision by filing the attached form Application for Review with the Employment Appeals Board within 20 days of the date that this decision is mailed.” Order No. No. 21-UI-172895 at 3. Order No. No. 21-UI-172895 also stated on its Certificate of Mailing, “Any appeal from this Order must be filed on or before September 7, 2021 to be timely.”

**CONCLUSIONS AND REASONS:** Claimant’s late application for review of Order No. No. 21-UI-172895 is dismissed.

An application for review is timely if it is filed within 20 days of the date that the Office of Administrative Hearings (OAH) mailed the order for which review is sought. ORS 657.270(6); OAR 471-041-0070(1) (May 13, 2019). The 20-day filing period may be extended a “reasonable time” upon a showing of “good cause.” ORS 657.875; OAR 471-041-0070(2). “Good cause” means that factors or circumstances beyond the applicant’s reasonable control prevented timely filing. OAR 471-041-0070(2)(a). A “reasonable time” is seven days after the circumstances that prevented the timely filing ceased to exist. OAR 471-041-0070(2)(b). A late application for review will be dismissed unless it includes a written statement describing the circumstances that prevented a timely filing. OAR 471-041-0070(3).

The application for review of Order No. 21-UI-172895 was due by September 7, 2021. Because claimant did not file their application for review until November 5, 2021, the application for review was late. Claimant provided several written statements by email on November 7, 2021 and November 8, 2021 regarding the application for review. However, claimant's written statements did not describe the circumstances that prevented claimant from filing the application for review on time.<sup>1</sup> Accordingly, claimant did not show good cause for the late application for review, and claimant's late application for review is dismissed.

**DECISION:** The application for review filed November 5, 2021 is dismissed. Order No. 21-UI-172895 remains undisturbed.

<sup>1</sup> Claimant's emails asserted that they should have prevailed at the hearing by default because the employer failed to appear for the hearing. However, the hearing was scheduled as a result of *claimant's* request for hearing. A dismissal of a request for hearing due to a party's failure to appear at the hearing is proper only when the party who failed to appear is the *same party who requested the hearing*. Because the employer did not request the hearing, the employer's failure to appear was not an appropriate basis for dismissing claimant's hearing request. Additionally, had the administrative law judge dismissed the hearing due to the employer's failure to appear, the result would have been to leave decision # 110825 undisturbed without giving claimant the right to a hearing—not to enter a default ruling in favor of the claimant.
