

EMPLOYMENT APPEALS BOARD DECISION
2021-EAB-0931

Late Applications for Review Dismissed

PROCEDURAL HISTORY: On October 30, 2020, the Oregon Employment Department (the Department) served notice of an administrative decision concluding that claimant willfully made a misrepresentation and failed to report a material fact to obtain unemployment insurance benefits, and assessing a \$1,636 overpayment that claimant was required to repay to the Department, a \$409 monetary penalty, and a 15-week penalty disqualification from future benefits (decision # 200557). On November 19, 2020, decision # 200557 became final without claimant having filed a request for hearing. On May 17, 2021, the Department served notice of an administrative decision concluding that claimant voluntarily quit work without good cause and was disqualified from receiving benefits effective March 14, 2021 (decision # 84800). On June 7, 2021, decision # 84800 became final without claimant having filed a request for hearing. On August 2, 2021, claimant filed late requests for hearing on decisions # 200557 and 84800.

ALJ Kangas considered claimant's requests, and on August 31, 2021 issued Orders No. 21-UI-173692 and 21-UI-173693, dismissing claimant's requests for hearing on decisions # 200557 and 84800 as late, subject to claimant's right to renew the requests by responding to appellant questionnaires by September 14, 2021. On September 20, 2021, Orders No. 21-UI-173692 and 21-UI-173693 became final without claimant having filed responses to the appellant questionnaires with the Office of Administrative Hearings (OAH) or applications for review with the Employment Appeals Board (EAB). On November 5, 2021, claimant filed late applications for review of Orders No. 21-UI-173692 and 21-UI-173693 with EAB.

Pursuant to OAR 471-041-0095 (October 29, 2006), EAB consolidated its review of Orders No. 21-UI-173692 and 21-UI-173693. For case-tracking purposes, this decision is being issued in duplicate (EAB Decisions 2021-EAB-0930 and 2021-EAB-0931).

FINDINGS OF FACT: (1) Order No. 21-UI-173692, mailed to claimant on August 31, 2021, stated, "You may appeal this decision by filing the attached form Application for Review with the Employment Appeals Board within 20 days of the date that this decision is mailed." Order No. 21-UI-173692 at 2. Order No. 21-UI-173692 also stated on its Certificate of Mailing, "Any party may appeal this Order by filing a Request for Review with the Employment Appeals Board no later than September 20, 2021."

(2) Order No. 21-UI-173693, mailed to claimant on August 31, 2021, stated, “You may appeal this decision by filing the attached form Application for Review with the Employment Appeals Board within 20 days of the date that this decision is mailed.” Order No. 21-UI-173693 at 2. Order No. 21-UI-173693 also stated on its Certificate of Mailing, “Any party may appeal this Order by filing a Request for Review with the Employment Appeals Board no later than September 20, 2021.”

CONCLUSIONS AND REASONS: Claimant’s late applications for review of Orders No. 21-UI-173692 and 21-UI-173693 are dismissed.

An application for review is timely if it is filed within 20 days of the date that OAH mailed the order for which review is sought. ORS 657.270(6); OAR 471-041-0070(1) (May 13, 2019). The 20-day filing period may be extended a “reasonable time” upon a showing of “good cause.” ORS 657.875; OAR 471-041-0070(2). “Good cause” means that factors or circumstances beyond the applicant’s reasonable control prevented timely filing. OAR 471-041-0070(2)(a). A “reasonable time” is seven days after the circumstances that prevented the timely filing ceased to exist. OAR 471-041-0070(2)(b). A late application for review will be dismissed unless it includes a written statement describing the circumstances that prevented a timely filing. OAR 471-041-0070(3).

The applications for review of Orders No. 21-UI-173692 and 21-UI-173693 were due by September 20, 2021. Because claimant did not file their applications for review until November 5, 2021, the applications for review were late. Claimant provided a written statement with the applications for review. However, claimant’s written statement did not describe the circumstances that prevented them from filing the applications for review on time. Accordingly, claimant did not show good cause for the late applications for review, and claimant’s late applications for review are dismissed.

DECISION: The applications for review filed November 5, 2021 are dismissed. Orders No. 21-UI-173692 and 21-UI-173693 remain undisturbed.
