

EMPLOYMENT APPEALS BOARD DECISION
2021-EAB-0938

Affirmed
No Disqualification

PROCEDURAL HISTORY: On September 22, 2021, the Oregon Employment Department (the Department) served notice of an administrative decision concluding that claimant was discharged but not for misconduct and was not disqualified from receiving unemployment insurance benefits based on the work separation (decision # 105742). The employer filed a timely request for hearing. On October 27, 2021, ALJ Janzen conducted a hearing, and on October 28, 2021 issued Order No. 21-UI-178327, concluding affirming decision # 105742. On November 5, 2021, the employer filed an application for review with the Employment Appeals Board (EAB).

EVIDENTIARY MATTER: On November 11, 2021, the employer submitted to EAB a video showing the truck accident that preceded claimant's discharge in this matter. The employer had sought to admit the video at hearing but the ALJ did not admit it due to the employer having failed to serve claimant with it prior to the commencement of the hearing. *See* Audio Record at 5:07 to 7:15; OAR 471-040-0023(4). To the extent the employer intended for EAB to consider the video as argument under OAR 471-041-0080, the employer's argument contained information that was not part of the hearing record, and did not show that factors or circumstances beyond the employer's reasonable control prevented them from offering the information during the hearing. Under ORS 657.275(2) and OAR 471-041-0090 (May 13, 2019), EAB considered only information received into evidence at the hearing when reaching this decision. To the extent the employer submitted the video to EAB intending for EAB to receive it as additional evidence necessary to complete the record under OAR 471-041-0090(1), EAB declines to receive the video into the hearing record because review of the video indicates that the video does not show the speed at which claimant was driving or otherwise provide evidence probative of whether claimant's conduct constituted misconduct. Accordingly, the video is not relevant and material to EAB's determination under OAR 471-041-0090(1)(b)(A), and the employer's request for EAB to receive it into the record is denied.

EAB reviewed the entire hearing record. On *de novo* review and pursuant to ORS 657.275(2), the order under review is **adopted**.

DECISION: Order No. 21-UI-178327 is affirmed.
