# EMPLOYMENT APPEALS BOARD DECISION 2021-EAB-0943

Late Application for Review Dismissed

PROCEDURAL HISTORY: On April 29, 2021, the Oregon Employment Department (the Department) served notice of an administrative decision concluding that claimant was not able to work and was therefore not eligible to receive unemployment insurance benefits for the weeks from March 14, 2021 through April 17, 2021 and until the reason for the denial had ended (decision #85418). On May 19, 2021, decision #85418 became final without claimant having filed a request for hearing. On July 14, 2021, claimant filed a late request for hearing. ALJ Kangas considered claimant's request, and on August 2, 2021 issued Order No. 21-UI-171619, dismissing the request as late, subject to claimant's right to renew the request by responding to an appellant questionnaire by August 16, 2021. On August 7, 2021, claimant filed a timely response to the appellant questionnaire. ALJ S. Lee reviewed claimant's response, and on October 13, 2021 issued Order No. 21-UI-177112, cancelling Order No. 21-UI-171619 and re-dismissing claimant's request for hearing as late without a showing of good cause, leaving decision #85418 undisturbed. On November 2, 2021, Order No. 21-UI-177112 became final without claimant having filed an application for review with the Employment Appeals Board (EAB). On November 3, 2021, claimant filed a late application for review of Order No. 21-UI-177112 with EAB.

**FINDINGS OF FACT:** (1) Order No. 21-UI-177112, mailed to claimant on October 13, 2021, stated, "You may appeal this decision by filing the attached form Application for Review with the Employment Appeals Board within 20 days of the date that this decision is mailed." Order No. 21-UI-177112 at 3. Order No. 21-UI-177112 also stated on its Certificate of Mailing, "Any appeal from this Order must be filed on or before November 2, 2021 to be timely."

**CONCLUSIONS AND REASONS:** Claimant's late application for review of Order No. 21-UI-177112 is dismissed.

An application for review is timely if it is filed within 20 days of the date that the Office of Administrative Hearings (OAH) mailed the order for which review is sought. ORS 657.270(6); OAR 471-041-0070(1) (May 13, 2019). The 20-day filing period may be extended a "reasonable time" upon a showing of "good cause." ORS 657.875; OAR 471-041-0070(2). "Good cause" means that factors or circumstances beyond the applicant's reasonable control prevented timely filing. OAR 471-041-0070(2)(a). A "reasonable time" is seven days after the circumstances that prevented the timely filing

ceased to exist. OAR 471-041-0070(2)(b). A late application for review will be dismissed unless it includes a written statement describing the circumstances that prevented a timely filing. OAR 471-041-0070(3).

The application for review of Order No. 21-UI-177112 was due by November 2, 2021. Because claimant did not file their application for review until November 3, 2021, the application for review was late. Claimant provided a written statement with the application for review. However, claimant's written statement did not describe the circumstances that prevented claimant from filing the application for review on time. Accordingly, claimant did not show good cause for the late application for review, and claimant's late application for review is dismissed.

**DECISION:** The application for review filed November 3, 2021 is dismissed. Order No. 21-UI-177112 remains undisturbed.
