EMPLOYMENT APPEALS BOARD DECISION 2021-EAB-0950

Reversed & Remanded

PROCEDURAL HISTORY: On June 18, 2021, the Oregon Employment Department (the Department) served notice of an administrative decision concluding that claimant voluntarily quit work without good cause and was disqualified from receiving unemployment insurance benefits effective April 18, 2021 (decision # 140854). On July 8, 2021, decision # 140854 became final without claimant having filed a request for hearing. On July 13, 2021, claimant filed a late request for hearing. ALJ Kangas considered claimant's request, and on July 21, 2021 issued Order No. 21-UI-170864, dismissing claimant's request for hearing as late, subject to claimant's right to renew the request by responding to an appellant questionnaire by August 4, 2021. On August 2, 2021, claimant filed a timely response to the appellant questionnaire. ALJ S. Lee considered claimant's response, and on October 21, 2021, issued Order No. 21-UI-177755, re-dismissing claimant's late request for hearing, and leaving decision # 140854 undisturbed. On November 8, 2021, claimant filed an application for review of Order No. 21-UI-177755 with the Employment Appeals Board (EAB).

EVIDENTIARY MATTER: EAB has considered additional evidence when reaching this decision under OAR 471-041-0090(1) (May 13, 2019). The additional evidence is claimant's response to the appellant questionnaire, marked as EAB Exhibit 1, and a copy provided to the parties with this decision. Any party that objects to our admitting EAB Exhibit 1 must submit such objection to this office in writing, setting forth the basis of the objection in writing, within ten days of our mailing this decision. OAR 471-041-0090(2). Unless such objection is received and sustained, the exhibit will remain in the record.

FINDINGS OF FACT: (1) Employment Department records showed the following entry in their records on June 29, 2021: "Climt request to file appeal for denial."

(2) On November 8, 2021, claimant stated on their application for review to EAB, "The case worker I spoke to said they fixed the request for a hearing." EAB Exhibit 1 at 2.

CONCLUSIONS AND REASONS: Order No. 21-UI-177755 is set aside and this matter remanded for a hearing on whether claimant's late request for hearing on decision # 140854 should be allowed and, if so, the merits of that decision.

ORS 657.269 provides that the Department's decisions become final unless a party files a request for hearing within 20 days after the date the decision is mailed. ORS 657.875 provides that the 20-day deadline may be extended a "reasonable time" upon a showing of "good cause." OAR 471-040-0010 (February 10, 2012) provides that "good cause" includes factors beyond an applicant's reasonable control or an excusable mistake, and defines "reasonable time" as seven days after those factors ceased to exist.

Claimant's request for hearing on decision # 140854 was due by July 8, 2021. Because claimant did not file their request for hearing until July 13, 2021, the request was late. However, the record under review indicates that claimant may have contacted the Employment Department and filed a request for hearing on June 29, 2021. The record shows that the Department may have considered the request defective in some manner, but that claimant apparently "fixed" the request for hearing on July 13, 2021 with the assistance of a Department "case worker." Claimant may have filed a timely request for hearing. Alternately, claimant may have filed their request for hearing late due to an excusable mistake or factors beyond claimant's reasonable control.

The record is insufficient to determine what occurred on June 29, 2021 when claimant apparently contacted the Department to request to file an appeal. If claimant's request was somehow deficient at that time, it may have been due to an excusable mistake or a factor beyond claimant's reasonable control. Further, to the extent that claimant may have had good cause for filing a late request for hearing, the record is insufficient to determine whether claimant's July 13, 2021 late request for hearing was filed within a reasonable time, that is, within seven days after the circumstances that prevented a timely filing ceased to exist. Because further development of the record is necessary for a determination of whether claimant's late request for hearing should be allowed, this matter is remanded for a hearing and order. If the ALJ concludes that claimant filed a request for hearing that should be allowed, the ALJ must then develop a record on the merits of decision # 140854.

DECISION: Order No. 21-UI-177755 is set aside, and this matter remanded for further proceedings consistent with this order.
