EMPLOYMENT APPEALS BOARD DECISION 2021-EAB-0954

Late Applications for Review Dismissed

PROCEDURAL HISTORY: On June 11, 2021, the Oregon Employment Department (the Department) served notice of an administrative decision concluding that claimant filed late claims for unemployment insurance benefits for the weeks from January 24, 2021 through March 20, 2021 (weeks 04-21 through 11-21) and therefore was denied benefits for those weeks (decision # 143920). Also on June 11, 2021, the Department served notice of an administrative decision concluding that claimant filed late claims for benefits for the weeks from March 21, 2021 through May 15, 2021 (weeks 12-21 through 19-21) and therefore was denied benefits for those weeks (decision # 151323). On July 1, 2021, decisions # 143920 and 151323 became final without claimant having filed a request for hearing.

On July 28, 2021, claimant filed late requests for hearing on decisions # 143920 and 151323. ALJ Kangas considered claimant's requests, and on October 12, 2021 issued Orders No. 21-UI-176924 and 21-UI-176921, dismissing the requests as late subject to claimant's right to renew the requests by responding to an appellant questionnaire by October 26, 2021. On November 1, 2021, Orders No. 21-UI-176924 and 21-UI-176921 became final without claimant having responded to the appellant questionnaires or filed applications for review of either order.

On October 28, 2021 claimant filed a late response to the appellant questionnaire. On November 1, 2021, ALJ Kangas mailed a letter stating that the Office of Administrative Hearings (OAH) would not consider claimant's questionnaire response or issue another order regarding claimant's late request for hearing on decision # 143920 because the questionnaire response was late. On November 11, 2021, claimant filed late applications for review of Orders No. 21-UI-176924 and 21-UI-176921 with the Employment Appeals Board (EAB).

¹ The Office of Administrative Hearings (OAH) did not apply claimant's questionnaire response to Case No. 2021-UI-47307 (Order No. 21-UI-176921). However, it does not change the outcome in that case because the questionnaire response was late, and OAH therefore would not have considered the response.

Pursuant to OAR 471-041-0095 (October 29, 2006), EAB consolidated its review of Orders No. 21-UI-176924 and 21-UI-176921. For case-tracking purposes, this decision is being issued in duplicate (EAB Decisions 21-EAB-0953 and 21-EAB-0954).

EVIDENTIARY MATTER: EAB has considered additional evidence when reaching this decision under OAR 471-041-0090(1) (May 13, 2019). The additional evidence is claimant's statement submitted with their applications for review, and has been marked as EAB Exhibit 1, and a copy provided to the parties with this decision. Any party that objects to our admitting EAB Exhibit 1 must submit such objection to this office in writing, setting forth the basis of the objection in writing, within ten days of our mailing this decision. OAR 471-041-0090(2). Unless such objection is received and sustained, the exhibit(s) will remain in the record.

FINDINGS OF FACT: (1) Order No. 21-UI-176924, mailed to claimant on October 12, 2021, stated, "You may appeal this decision by filing the attached form Application for Review with the Employment Appeals Board within 20 days of the date that this decision is mailed." Order No. 21-UI-176924 at 2. Order No. 21-UI-176924 also stated on its Certificate of Mailing, "Any party may appeal this Order by filing a Request for Review with the Employment Appeals Board no later than November 1, 2021."

(2) Order No. 21-UI-176921, mailed to claimant on October 12, 2021, stated, "You may appeal this decision by filing the attached form Application for Review with the Employment Appeals Board within 20 days of the date that this decision is mailed." Order No. 21-UI-176921 at 2. Order No. 21-UI-176921 also stated on its Certificate of Mailing, "Any party may appeal this Order by filing a Request for Review with the Employment Appeals Board no later than November 1, 2021."

CONCLUSIONS AND REASONS: Claimant's late applications for review of Orders No. 21-UI-176924 and 21-UI-176921 are dismissed.

An application for review is timely if it is filed within 20 days of the date that the Office of Administrative Hearings (OAH) mailed the order for which review is sought. ORS 657.270(6); OAR 471-041-0070(1) (May 13, 2019). The 20-day filing period may be extended a "reasonable time" upon a showing of "good cause." ORS 657.875; OAR 471-041-0070(2). "Good cause" means that factors or circumstances beyond the applicant's reasonable control prevented timely filing. OAR 471-041-0070(2)(a). A "reasonable time" is seven days after the circumstances that prevented the timely filing ceased to exist. OAR 471-041-0070(2)(b). A late application for review will be dismissed unless it includes a written statement describing the circumstances that prevented a timely filing. OAR 471-041-0070(3).

The applications for review of Orders No. 21-UI-176924 and 21-UI-176921 were due by November 1, 2021. Because claimant did not file their applications for review until November 11, 2021, the applications for review were late. Claimant provided a written statement with the applications for review. *See* EAB Exhibit 1. However, claimant's written statement did not describe the circumstances that prevented them from filing the applications for review on time. Accordingly, claimant did not show good cause for the late applications for review, and claimant's late applications for review are dismissed.

DECISION: The applications for review filed November 11, 2021 are dismissed. Orders No. 21-UI-176924 and 21-UI-176921 remain undisturbed.
