EMPLOYMENT APPEALS BOARD DECISION 2021-EAB-0963

Affirmed Late Claims for Benefits Denied Ineligible Weeks 27-21 through 33-21

PROCEDURAL HISTORY: On September 22, 2021, the Oregon Employment Department (the Department) served notice of an administrative decision concluding that claimant filed late claims for unemployment insurance benefits for the weeks from July 4, 2021 through August 21, 2021 (weeks 27-21 through 33-21) and was denied benefits for those weeks (decision # 143128). Claimant filed a timely request for hearing. On November 1, 2021, ALJ Murdock conducted a hearing, and on November 2, 2021 issued Order No. 21-UI-178744, affirming decision # 143128. On November 13, 2021, claimant filed an application for review with the Employment Appeals Board (EAB).

WRITTEN ARGUMENT: Claimant submitted written arguments on November 15, 2021 and November 30, 2021. Claimant's arguments contained information that was not part of the hearing record, and did not show that factors or circumstances beyond claimant's reasonable control prevented them from offering the information during the hearing. Under ORS 657.275(2) and OAR 471-041-0090 (May 13, 2019), EAB considered only information received into evidence at the hearing when reaching this decision. EAB considered claimant's arguments to the extent they were based on the record.

In claimant's arguments, claimant essentially asserted that the online claim system would not allow her to submit her weekly claims for benefits because the Department had determined that her claim was monetarily non-valid as a result of the employer's having failed to submit accurate information about the hours she had worked during her base year. *See* November 30, 2021 "Claimant's Statement" at 1. However, the Department's witness testified that the online claim system does not prevent a claimant from submitting weekly claims for benefits when an initial claim is in "non-valid" status. When asked by the ALJ: "Well . . . so would there have been a problem with her claiming each week while the claim was non-valid?" the Department witness responded: "No." Transcript at 32. The Department witness then added, "the Wage and Potential Benefit Report that she got that said her claim was non-valid . . . [also notified claimant] . . . "you need to claim weeks of unemployment benefits through the system while you're waiting for your claim to go through, uh, for things to be resolved." Transcript at 32. Although the evidence in the record regarding whether the Department's online claim system prevented claimant from filing weekly claims for benefits for the weeks at issue may have been no more than

equally balanced, claimant had the burden of proof on that issue. *See Nichols v. Employment Division*, 24 Or App 195, 544 P2d 1068 (1976) (where the Department has paid benefits it has the burden to prove benefits should not have been paid; by logical extension of that principle, where benefits have not been paid claimant has the burden to prove that the Department should have paid benefits).

In addition, a continued claim, such as each of claimant's weekly claims for benefits, may be filed in person at any Employment Department office in the state of Oregon, by United States mail, by fax, by internet, or by telephone. OAR 471-030-0045(3)(a)-(e) (January 11, 2018). For that reason, claimant had the option to timely file each of her weekly claims for benefits in person, by mail or by fax, in addition to her attempts to file them online or by phone. Finally, OAR 471-030-0045(4) which required that each of claimant's continued claims for benefits be filed no later than seven days after the end of the week claimed (or, in the case of the first effective week of the claim, 13 days), contains no good-cause exception for failing to file a timely continued claim.

For all of these reasons, claimant's continued claims for benefits, each of which was filed on September 15, 2021, were late and for that reason those claims for benefits were correctly denied.

EAB reviewed the entire hearing record. On *de novo* review and pursuant to ORS 657.275(2), the order under review is **adopted**.

DECISION: Order No. 21-UI-178744 is affirmed.
