# EMPLOYMENT APPEALS BOARD DECISION 2021-EAB-0964

#### Late Application for Review Dismissed

PROCEDURAL HISTORY: On December 4, 2020, the Oregon Employment Department (the Department) served notice of an administrative decision concluding claimant quit working for the employer without good cause and was disqualified from receiving unemployment insurance benefits beginning June 14, 2020 (decision #153802). On December 24, 2020, decision #153802 became final without claimant having filed a request for hearing. On January 1, 2021, claimant filed a late request for hearing. ALJ Kangas considered claimant's request, and on January 25, 2021 issued Order No. 21-UI-159711, dismissing claimant's request for hearing as late, subject to claimant's right to renew the request by filing a response to an appellant questionnaire by February 8, 2021. On February 16, 2021, Order No. 21-UI-159711 became final without claimant having responded to the appellant questionnaire or filed an application for review of Order No. 21-UI-159711 with the Employment Appeals Board (EAB). On February 17, 2021, claimant filed a late response to the appellant questionnaire and a late application for review of Order No. 21-UI-159711 with EAB. On March 15, 2021, ALJ Kangas issued a letter stating that the Office of Administrative Hearings (OAH) would not consider claimant's questionnaire response or issue another order because the questionnaire response was late. This matter comes before EAB based upon claimant's February 17, 2021 late application for review of Order No. 21-UI-159711.

**FINDINGS OF FACT:** (1) Order No. 21-UI-159711, mailed to claimant on January 25, 2021, stated, "You may appeal this decision by filing the attached form Application for Review with the Employment Appeals Board within 20 days of the date that this decision is mailed." Order No. 21-UI-159711 at 2. Order No 21-UI-159711 also stated on its Certificate of Mailing, "Any party may appeal this Order by filing a Request for Review with the Employment Appeals Board no later than February 16, 2021."

**CONCLUSIONS AND REASONS:** Claimant's late application for review of Order No. 21-UI-159711 is dismissed.

An application for review is timely if it is filed within 20 days of the date that the Office of Administrative Hearings (OAH) mailed the order for which review is sought. ORS 657.270(6); OAR 471-041-0070(1) (May 13, 2019). The 20-day filing period may be extended a "reasonable time" upon a showing of "good cause." ORS 657.875; OAR 471-041-0070(2). "Good cause" means that factors or

circumstances beyond the applicant's reasonable control prevented timely filing. OAR 471-041-0070(2)(a). A "reasonable time" is seven days after the circumstances that prevented the timely filing ceased to exist. OAR 471-041-0070(2)(b). A late application for review will be dismissed unless it includes a written statement describing the circumstances that prevented a timely filing. OAR 471-041-041-0070(3).

The filing date for an application for review filed by mail is the postmark date affixed to the envelope in which the application was mailed. OAR 471-041-0065(1)(b) (May 13, 2019). The postmark date on the envelope in which claimant mailed their application for review was February 17, 2021; that date is therefore the filing date.<sup>1</sup>

The application for review of Order No. 21-UI-159711 was due by February 16, 2021. Because claimant did not file their application for review until February 17, 2021, the application for review was late. Claimant provided a written statement with the application for review. However, claimant's written statement did not describe the circumstances that prevented them from filing the application for review on time. Accordingly, claimant did not show good cause for the late application for review, and claimant's late application for review is dismissed.

**DECISION:** The application for review filed February 17, 2021 is dismissed. Order No. 21-UI-159711 remains undisturbed.
