EMPLOYMENT APPEALS BOARD DECISION 2021-EAB-0978

Late Application for Review Dismissed

PROCEDURAL HISTORY: On July 6, 2021, the Oregon Employment Department (the Department) served notice of an administrative decision concluding that claimant failed to register for work in accordance with the Department's rules and therefore was ineligible to receive unemployment insurance benefits for the week of June 13, 2021 through June 19, 2021 (week 24-21) and until the reason for the denial ended. On July 26, 2021, the July 6, 2021 administrative decision became final without claimant having filed a request for hearing. On August 22, 2021, claimant filed a late request for hearing on the July 6, 2021 administrative decision.

ALJ Kangas considered claimant's request, and on October 14, 2021 issued Order No. 21-UI-177136, dismissing claimant's request for hearing as late, subject to claimant's right to renew the request by responding to an appellant questionnaire by October 28, 2021. On November 3, 2021, Order No. 21-UI-177136 became final without claimant having filed a response to the appellant questionnaire with the Office of Administrative Hearings (OAH) or an application for review with the Employment Appeals Board (EAB). On November 9, 2021, claimant filed a late application for review of Order No. 21-UI-177136 with EAB.

FINDING OF FACT: (1) Order No. 21-UI-177136, mailed to claimant on October 14, 2021, stated, "You may appeal this decision by filing the attached form Application for Review with the Employment Appeals Board within 20 days of the date that this decision is mailed." Order No. 21-UI-177136 at 2. Order No. 21-UI-177136 also stated on its Certificate of Mailing, "Any party may appeal this Order by filing a Request for Review with the Employment Appeals Board no later than November 3, 2021."

CONCLUSIONS AND REASONS: Claimant's late application for review of Order No. 21-UI-177136 is dismissed.

An application for review is timely if it is filed within 20 days of the date that OAH mailed the order for which review is sought. ORS 657.270(6); OAR 471-041-0070(1) (May 13, 2019). The 20-day filing period may be extended a "reasonable time" upon a showing of "good cause." ORS 657.875; OAR 471-041-0070(2). "Good cause" means that factors or circumstances beyond the applicant's reasonable control prevented timely filing. OAR 471-041-0070(2)(a). A "reasonable time" is seven days after the

circumstances that prevented the timely filing ceased to exist. OAR 471-041-0070(2)(b). A late application for review will be dismissed unless it includes a written statement describing the circumstances that prevented a timely filing. OAR 471-041-0070(3).

The application for review of Order No. 21-UI-177136 was due by November 3, 2021. Because claimant did not file their application for review until November 9, 2021, the application for review was late. Claimant provided a written statement with the application for review. However, claimant's written statement did not describe the circumstances that prevented claimant from filing the application for review on time. Accordingly, Claimant did not show good cause for the late application for review, and claimant's late application for review is dismissed.

DECISION: The application for review filed November 9, 2021 is dismissed. Order No. 21-UI-177136 remains undisturbed.
