

EMPLOYMENT APPEALS BOARD DECISION
2021-EAB-0998

Affirmed
Overpayment No Penalties

PROCEDURAL HISTORY: On March 11, 2021, the Oregon Employment Department (the Department) served notice of an administrative decision concluding that claimant willfully made a misrepresentation and failed to report a material fact to obtain unemployment insurance benefits, and assessing a \$1,071.00 overpayment of regular benefits, a \$4,200.00 overpayment of Federal Pandemic Unemployment Compensation (FPUC) benefits, a \$321.30 monetary penalty, and a seven-week penalty disqualification from future benefits. Claimant filed a timely request for hearing. On November 18, 2021, ALJ Scott conducted a hearing, at which the employer failed to appear, and on November 19, 2021 issued Order No. 21-UI-180132, modifying the March 11, 2021 administrative decision by concluding that claimant was liable to repay the \$1,071.00 overpayment of regular benefits and the \$4,200.00 overpayment of FPUC benefits, but was not liable for the monetary penalty or penalty weeks. On November 24, 2021, the employer filed an application for review with the Employment Appeals Board (EAB).¹

EAB reviewed the entire hearing record. On *de novo* review and pursuant to ORS 657.275(2), the order under review is **adopted**.

DECISION: Order No. 21-UI-180132 is affirmed.

¹ EAB treated the employer's application for review as an application for review rather than as a request to reopen the November 18, 2020 hearing because, although the employer did not appear at the hearing, per OAR 471-041-0060(5), the employer did not include in their application for review a written statement that sets forth the reason(s) for missing the hearing.
