# EMPLOYMENT APPEALS BOARD DECISION 2021-EAB-1007-R

Request for Reconsideration Allowed EAB Decision 2021-EAB-1007 Adhered to on Reconsideration

PROCEDURAL HISTORY AND FINDINGS OF FACT: On September 29, 2021, the Oregon Employment Department (the Department) served a Notice of Determination for Pandemic Unemployment Assistance (PUA) concluding that claimant was not entitled to receive PUA benefits effective December 6, 2020. Claimant filed a timely request for hearing. On November 12, 2021, ALJ Janzen conducted a hearing, and on November 17, 2021 issued Order No. 21-UI-179852, affirming the September 29, 2021 administrative decision and concluding that claimant was not eligible to receive PUA benefits for the weeks including September 13, 2020 through September 4, 2021 (weeks 38-20 through 35-21). On November 25, 2021, claimant filed an application for review with the Employment Appeals Board (EAB). On December 30, 2021, EAB issued EAB Decision 2021-EAB-1007, affirming Order No. 21-UI-179852. On December 30, 2021, claimant filed a request for reconsideration of EAB Decision 2021-EAB-1007 with EAB. This decision is issued pursuant to EAB's authority under ORS 657.290(3).

**CONCLUSIONS AND REASONS:** Claimant's request for reconsideration is allowed. EAB Decision 2021-EAB-1007 is adhered to on reconsideration.

ORS 657.290(3) authorizes EAB to reconsider any previous decision of EAB, including "the making of a new decision to the extent necessary and appropriate for the correction of previous error of fact or law." "Any party may request reconsideration to correct an error of material fact or law, or to explain any unexplained inconsistency with Employment Department rule, or officially stated Employment Department position, or prior Employment Department practice." OAR 471-041-0145(1) (May 13, 2019). The request is subject to dismissal unless it includes a statement that a copy was provided to the other parties, and is filed on or before the 20<sup>th</sup> day after the decision sought to be reconsidered was mailed. OAR 471-041-0145(2).

<sup>&</sup>lt;sup>1</sup> Order No. 21-UI-179852 stated in the history of the case that the September 29, 2021 administrative decision concluded that "claimant was entitled to receive [PUA benefits]." Order No. 21-UI-179852 at 1. Because the September 29, 2021 administrative decision concluded that claimant was not entitled to PUA benefits, this is assumed to be a scrivener's error.

EAB issued EAB Decision 2021-EAB-1007 on December 30, 2021. Claimant filed their request for reconsideration on December 30, 2021, the same day that EAB Decision 2021-EAB-1007 was issued. Claimant's request for reconsideration therefore was timely, and is allowed.

Claimant contends in their request for reconsideration that EAB failed to consider the new evidence they presented in the proceedings in EAB case 2021-EAB-1007. However, that issue was addressed adequately in EAB Decision 2021-EAB-1007 inasmuch as EAB Decision 2021-EAB-1007 informed claimant that the new evidence they attempted to provide had not been a part of the hearing record and that claimant had not otherwise shown that factors or circumstances beyond claimant's reasonable control prevented them from offering the information during the hearing. Accordingly, EAB Decision 2021-EAB-1007 is adhered to on reconsideration.

**DECISION:** Claimant's request for reconsideration of EAB Decision 2021-EAB-1007 is allowed. On reconsideration, EAB Decision 2021-EAB-1007 is adhered to as clarified herein.
