

EMPLOYMENT APPEALS BOARD DECISION
2021-EAB-1012

Affirmed
Request to Reopen Denied

PROCEDURAL HISTORY: On April 14, 2021, the Oregon Employment Department (the Department) served notice of an administrative decision concluding that the employer discharged claimant, but not for misconduct, and that claimant therefore was not disqualified from receiving unemployment insurance benefits based on the work separation (decision # 121254). The employer filed a timely request for hearing. On May 26, 2021, the Office of Administrative Hearings (OAH) served notice of a hearing scheduled for June 11, 2021 at 8:15 a.m. On June 11, 2021, ALJ Janzen conducted a hearing at which claimant failed to appear, and on June 15, 2021 issued Order No. 21-UI-168704, reversing decision # 121254 by concluding that the employer discharged claimant for misconduct, disqualifying claimant from receiving benefits effective March 7, 2021. On July 6, 2021, Order No. 21-UI-168704 became final without claimant having filed a timely request to reopen the June 11, 2021 hearing. On August 3, 2021, claimant filed a late request to reopen the hearing. ALJ Kangas considered claimant's request, and on November 10, 2021 issued Order No. 21-UI-179414, denying claimant's request to reopen as late without good cause, leaving Order No. 21-UI-168704 undisturbed. On November 28, 2021, claimant filed a timely application for review of Order No. 21-UI-179414 with the Employment Appeals Board (EAB).

WRITTEN ARGUMENT: Claimant did not declare that they provided a copy of their argument to the opposing party or parties as required by OAR 471-041-0080(2)(a) (May 13, 2019). The argument also contained information that was not part of the hearing record, and did not show that factors or circumstances beyond claimant's reasonable control prevented them from offering the information into the hearing record as required by OAR 471-041-0090 (May 13, 2019). EAB considered only information received into the hearing record when reaching this decision. *See* ORS 657.275(2).

EAB reviewed the entire hearing record. On *de novo* review and pursuant to ORS 657.275(2), the order under review is **adopted**.

DECISION: Order No. 21-UI-179414 is affirmed.
