

EMPLOYMENT APPEALS BOARD DECISION
2021-EAB-1013

Affirmed
Request to Reopen Denied

PROCEDURAL HISTORY: On January 13, 2021, the Oregon Employment Department (the Department) served notice of an administrative decision concluding that the employer discharged claimant for misconduct and that claimant was therefore disqualified from receiving unemployment insurance benefits effective July 12, 2020 (decision # 93516). Claimant filed a timely request for hearing. On July 12, 2021, the Office of Administrative Hearings (OAH) served notice of a hearing scheduled for July 19, 2021 at 2:30 p.m. On July 19, 2021, claimant failed to appear at the hearing, and ALJ Mott issued Order No. 21-UI-170616, dismissing claimant's request for hearing for failure to appear. On July 22, 2021, claimant filed a timely request to reopen the hearing. ALJ Kangas reviewed claimant's request to reopen, and on November 10, 2021, issued Order No. 21-UI-179482, denying claimant's request to reopen the hearing and leaving Order No. 21-UI-170616 undisturbed. On November 29, 2021, claimant filed an application for review with the Employment Appeals Board (EAB).

EAB reviewed the entire hearing record. On *de novo* review and pursuant to ORS 657.275(2), the order under review is **adopted**.

DECISION: Order No. 21-UI-179482 is affirmed.
