EMPLOYMENT APPEALS BOARD DECISION 2021-EAB-1021

Reversed & Remanded

PROCEDURAL HISTORY AND FINDINGS OF FACT: On August 6, 2021, the Oregon Employment Department (the Department) served notice of an administrative decision concluding that claimant quit working for the employer without good cause and was disqualified from receiving unemployment insurance benefits effective December 13, 2020 (decision # 131013). On August 26, 2021, decision # 131013 became final without claimant having filed a request for hearing. On September 15, 2021, claimant filed a late request for hearing. ALJ Kangas considered claimant's request, and on September 21, 2021 issued Order No. 21-UI-175200, dismissing the request as late, subject to claimant's right to renew the request by responding to an appellant questionnaire by October 5, 2021. On October 6, 2021, claimant filed a late response to the appellant questionnaire and a timely application for review of Order No. 21-UI-175200 with the Employment Appeals Board (EAB). On November 29, 2021, ALJ Kangas mailed a letter stating that the Office of Administrative Hearings (OAH) would not consider claimant's questionnaire response or issue another order regarding this matter because the questionnaire response was late. This matter comes before EAB based on claimant's October 6, 2021 application for review of Order No. 21-UI-175200.

EVIDENTIARY MATTER: EAB has considered additional evidence when reaching this decision under OAR 471-041-0090(1) (May 13, 2019). The additional evidence is claimant's response to the appellant questionnaire, marked as EAB Exhibit 1, and a copy provided to the parties with this decision. Any party that objects to our admitting EAB Exhibit 1 must submit such objection to this office in writing, setting forth the basis of the objection in writing, within ten days of our mailing this decision. OAR 471-041-0090(2). Unless such objection is received and sustained, the exhibit(s) will remain in the record.

CONCLUSIONS AND REASONS: Order No. 21-UI-175200 is set aside and this matter remanded for a hearing on whether claimant's late request for hearing on decision # 131013 should be allowed and, if so, the merits of that decision.

ORS 657.269 provides that the Department's decisions become final unless a party files a request for hearing within 20 days after the date the decision is mailed. ORS 657.875 provides that the 20-day

deadline may be extended a "reasonable time" upon a showing of "good cause." OAR 471-040-0010 (February 10, 2012) provides that "good cause" includes factors beyond an applicant's reasonable control or an excusable mistake, and defines "reasonable time" as seven days after those factors ceased to exist. Under OAR 471-040-0010(1)(a)(A), good cause includes failure to receive a document because the Department mailed it to an incorrect address despite having the correct address. Under OAR 471-040-0010(1)(b)(A), good cause does not include failure to receive a document due to not notifying the Department of an updated address while the person is claiming benefits or if the person knows, or reasonably should know, of a pending appeal.

The request for hearing on decision #131013 was due by August 26, 2021. Because claimant did not file their request for hearing until September 15, 2021, the request was late. In their appellant questionnaire response, claimant indicated that they did not receive decision #131013 until September 14, 2021 because they "moved out of state [and their] forwarding mail [was] a month behind." EAB Exhibit 1 at 1. If claimant did not receive the administrative decision until after the timely appeal deadline had passed, claimant may have filed the late request for hearing due to factors beyond their control. However, further inquiry is needed to determine whether claimant had good cause to file the late request for hearing, and filed the late request for hearing within a reasonable time. On remand, the ALJ should inquire as to when claimant moved and when, if at all, they notified the Department of their new address. The ALJ should also develop the record to show what efforts claimant made to retrieve any mail sent to the previous address and how they ultimately obtained decision #131013.

Order No. 21-UI-175200 therefore is reversed, and this matter remanded for a hearing on whether claimant's late request for hearing should be allowed and, if so, the merits of decision #131013.

DECISION: Order No. 21-UI-175200 is set aside, and this matter remanded for further proceedings consistent with this order.
