

EMPLOYMENT APPEALS BOARD DECISION
2021-EAB-1033

Orders No. 21-UI-180063, 21-UI-180065, and 21-UI-180062 Affirmed
Late Requests for Hearing Allowed
Ineligible Weeks 09-21 through 10-21, 12-21, and 14-21 through 15-21

PROCEDURAL HISTORY: On September 23, 2021, the Oregon Employment Department (the Department) served notice of an administrative decision concluding that claimant filed late claims for unemployment insurance benefits for the weeks including February 28, 2021 through March 13, 2021 (weeks 09-21 through 10-21) and therefore was denied benefits for those weeks (decision # 144344). Also on September 23, 2021, the Department served notice of an administrative decision concluding that claimant filed a late claim for unemployment insurance benefits for the week of March 21, 2021 through March 27, 2021 (week 12-21) and therefore was denied benefits for that week (decision # 171403). Also on September 23, 2021, the Department served notice of an administrative decision concluding that claimant filed late claims for unemployment insurance benefits for the weeks including April 4, 2021 through April 17, 2021 (weeks 14-21 through 15-21) and therefore was denied benefits for those weeks (decision # 172048). On October 13, 2021, decisions # 144344, 171403, and 172048 became final without claimant having filed requests for hearing. On October 20, 2021, claimant filed late requests for hearing on decisions # 144344, 171403, and 172048. On November 17, 2021, ALJ Frank conducted a consolidated hearing on decisions # 144344, 171403, and 172048. On November 18, 2021, ALJ Frank issued Orders No. 21-UI-180063, 21-UI-180065, and 21-UI-180062, concluding that claimant had good cause to file late requests for hearing on # 144344, 171403, and 172048, respectively, and affirming the merits of those decisions. On December 4, 2021, claimant filed applications for review of Orders No. 21-UI-180063, 21-UI-180065, and 21-UI-180062 with the Employment Appeals Board (EAB).

WRITTEN ARGUMENT: EAB considered claimant's written arguments when reaching this decision.

Pursuant to OAR 471-041-0095 (October 29, 2006), EAB consolidated its review of Orders No. 21-UI-180063, 21-UI-180065, and 21-UI-180062. For case-tracking purposes, this decision is being issued in triplicate (EAB Decisions 2021-EAB-1034, 2021-EAB-1035, and 2021-EAB-1033).

EAB reviewed the entire consolidated hearing record. On *de novo* review and pursuant to ORS 657.275(2), the orders under review are **adopted**.

DECISION: Orders No. 21-UI-180063, 21-UI-180065, and 21-UI-180062 are affirmed.
