EMPLOYMENT APPEALS BOARD DECISION 2021-EAB-1040

Late Application for Review Dismissed

PROCEDURAL HISTORY: On December 24, 2020, the Oregon Employment Department (the Department) served a Notice of Determination for Pandemic Unemployment Assistance (PUA) concluding that claimant was not entitled to receive PUA benefits effective February 2, 2020. On January 13, 2021, the December 24, 2020 administrative decision became final without claimant having filed a request for hearing. On October 21, 2021, claimant filed a late request for hearing. ALJ Kangas considered claimant's request, and on October 27, 2021 issued Order No. 21-UI-178227, dismissing claimant's request for hearing as late, subject to claimant's right to renew the request by responding to an appellant questionnaire by November 10, 2021. On November 16, 2021, Order No. 21-UI-178227 became final without claimant having filed a response to the appellant questionnaire or an application for review with the Employment Appeals Board (EAB). On December 8, 2021, claimant filed a late application for review of Order No. 21-UI-178227 with EAB.

WRITTEN ARGUMENT: Claimant filed a written argument by email on December 13, 2021. EAB considered claimant's argument when reaching this decision. Like the written statement claimant filed with their application for review, however, claimant's written argument did not describe the circumstances that prevented them from filing the application for review on time.

FINDING OF FACT: (1) Order No. 21-UI-178227, mailed to claimant on October 27, 2021, stated, "You may appeal this decision by filing the attached form Application for Review with the Employment Appeals Board within 20 days of the date that this decision is mailed." Order No. 21-UI-178227 at 2. Order No. 21-UI-178227 also stated on its Certificate of Mailing, "Any party may appeal this Order by filing a Request for Review with the Employment Appeals Board no later than November 16, 2021."

CONCLUSIONS AND REASONS: Claimant's late application for review of Order No. 21-UI-178227 is dismissed.

An application for review is timely if it is filed within 20 days of the date that the Office of Administrative Hearings (OAH) mailed the order for which review is sought. ORS 657.270(6); OAR 471-041-0070(1) (May 13, 2019). The 20-day filing period may be extended a "reasonable time" upon a showing of "good cause." ORS 657.875; OAR 471-041-0070(2). "Good cause" means that factors or

circumstances beyond the applicant's reasonable control prevented timely filing. OAR 471-041-0070(2)(a). A "reasonable time" is seven days after the circumstances that prevented the timely filing ceased to exist. OAR 471-041-0070(2)(b). A late application for review will be dismissed unless it includes a written statement describing the circumstances that prevented a timely filing. OAR 471-041-0070(3).

The application for review of Order No. 21-UI-178227 was due by November 16, 2021. Because claimant did not file their application for review until December 8, 2021, the application for review was late. Claimant provided a written statement with the application for review. However, claimant's written statement did not describe the circumstances that prevented them from filing the application for review on time. Accordingly, claimant did not show good cause for the late application for review, and claimant's late application for review is dismissed.

DECISION: The application for review filed December 8, 2021 is dismissed. Order No. 21-UI-178227 remains undisturbed.
