EMPLOYMENT APPEALS BOARD DECISION 2021-EAB-1050

Affirmed
Request to Reopen Denied

PROCEDURAL HISTORY: On March 13, 2020, the Oregon Employment Department (the Department) served notice of an administrative decision concluding that claimant was denied unemployment insurance benefits for the period from February 23, 2020 through February 29, 2020 (week 9-20) and until the reason for the denial had ended because claimant had not registered following the rules set by the Department. On April 2, 2020, the March 13, 2020 decision became final without claimant having filed a request for hearing. On August 11, 2020, claimant filed a late request for hearing. On September 17, 2020, ALJ Kangas issued Order No. 20-UI-154070 dismissing claimant's request for hearing as late, subject to claimant's right to renew the request by responding to an appellant questionnaire by October 1, 2020.

On October 3, 2020, claimant filed a late response to the appellant questionnaire and a timely application for review of Order No. 20-UI-154070 with the Employment Appeals Board (EAB). On December 22, 2020, ALJ Kangas mailed a letter stating that because claimant's response to the questionnaire was late, the Office of Administrative Hearings (OAH) would not consider it or issue another order, and Order No. 20-UI-154070 remained in effect. EAB considered the matter based upon claimant's timely application for review of Order No. 20-UI-154070. On December 30, 2020, EAB issued EAB Decision 2020-EAB-0803, reversing Order No. 20-UI-154070 and remanding the matter to OAH for further development of the record to determine whether claimant's late request for hearing on the March 13, 2020 administrative decision should be allowed, and if so, the merits of that decision.

On June 10, 2021, OAH served notice of a hearing scheduled for June 24, 2021, at 1:30 p.m. On June 24, 2021, claimant failed to appear for the hearing. On July 8, 2021, OAH served a new notice of a hearing scheduled for July 15, 2021 at 10:45 a.m. On July 15, 2021, ALJ Wyatt conducted a hearing at which claimant failed to appear, and on July 23, 2021, issued Order No. 21-UI-171017 re-dismissing claimant's late request for hearing on the March 13, 2020 administrative decision. On July 27, 2021, claimant filed a timely request to reopen the July 15, 2021 hearing. ALJ Kangas reviewed claimant's request to reopen, and on November 22, 2021, issued Order No. 21-UI-180261, denying the request and

leaving Order No. 21-UI-171017 undisturbed. On December 3, 2021, claimant filed an application for review of Order No. 21-UI-180261 with EAB.

WRITTEN ARGUMENT: Claimant's argument contained information that was not part of the hearing record, and did not show that factors or circumstances beyond claimant's reasonable control prevented them from offering the information during the hearing. Under ORS 657.275(2) and OAR 471-041-0090 (May 13, 2019), EAB considered only information received into evidence at the hearing when reaching this decision.

EAB reviewed the entire hearing record. On *de novo* review and pursuant to ORS 657.275(2), the order under review is **adopted**.

DECISION: Order No. 21-UI-180261 is affirmed.
