

EMPLOYMENT APPEALS BOARD DECISION
2021-EAB-1055

Late Application for Review Dismissed

PROCEDURAL HISTORY: On December 28, 2020, the Oregon Employment Department (the Department) served a Notice of Determination for Pandemic Unemployment Assistance (PUA) concluding that claimant was not entitled to receive PUA benefits effective February 2, 2020. Claimant filed a timely request for hearing. On February 16, 2021, ALJ M. Davis conducted a hearing, and on February 19, 2021, issued Order No. 21-UI-161280, modifying the December 28, 2020 administrative decision by concluding that claimant was entitled to receive PUA benefits for the weeks from March 8, 2020 through March 21, 2020, March 29, 2020 through July 25, 2020, August 2, 2020 through August 8, 2020, September 6, 2020 through September 12, 2020, October 4, 2020 through October 10, 2020, November 1, 2020 through November 7, 2020, and December 6, 2020 through February 6, 2021. On March 11, 2021, Order No. 21-UI-161280 became final without claimant having filed an application for review with the Employment Appeals Board (EAB). On December 3, 2021, claimant filed a late application for review of Order No. 21-UI-161280 with EAB.

EVIDENTIARY MATTER: EAB has considered additional evidence when reaching this decision under OAR 471-041-0090(1) (May 13, 2019). The additional evidence is the written statement claimant provided with their application for review, and has been marked as EAB Exhibit 1, and a copy provided to the parties with this decision. Any party that objects to our admitting EAB Exhibit 1 must submit such objection to this office in writing, setting forth the basis of the objection in writing, within ten days of our mailing this decision. OAR 471-041-0090(2). Unless such objection is received and sustained, the exhibit(s) will remain in the record.

FINDING OF FACTS: (1) Order No. 21-UI-161280, mailed to claimant on February 19, 2021, stated, "You may appeal this decision by filing the attached form Application for Review with the Employment Appeals Board within 20 days of the date that this decision is mailed." Order No. 21-UI-161280 at 4. Order No. 21-UI-161280 also stated on its Certificate of Mailing, "Any appeal from this Order must be filed on or before March 11, 2021 to be timely."

(2) Claimant is "disabled blind." EAB Exhibit 1 at 3.

(3) In August 2021, claimant was diagnosed with COVID-19, and quarantined.

CONCLUSIONS AND REASONS: Claimant’s late application for review of Order No. 21-UI-161280 is dismissed.

An application for review is timely if it is filed within 20 days of the date that the Office of Administrative Hearings (OAH) mailed the order for which review is sought. ORS 657.270(6); OAR 471-041-0070(1) (May 13, 2019). The 20-day filing period may be extended a “reasonable time” upon a showing of “good cause.” ORS 657.875; OAR 471-041-0070(2). “Good cause” means that factors or circumstances beyond the applicant’s reasonable control prevented timely filing. OAR 471-041-0070(2)(a). A “reasonable time” is seven days after the circumstances that prevented the timely filing ceased to exist. OAR 471-041-0070(2)(b). A late application for review will be dismissed unless it includes a written statement describing the circumstances that prevented a timely filing. OAR 471-041-0070(3).

The application for review of Order No. 21-UI-161280 was due by March 11, 2021. Because claimant did not file their application for review until December 3, 2021, the application for review was late. Claimant provided a written statement with the application for review. *See* EAB Exhibit 1. Claimant is blind. However, claimant’s written statement does not show how her visual impairment prevented her from filing her application for review of Order No. 21-UI-161280 by March 11, 2021. Similarly, although claimant had COVID-19 and was quarantined in August 2021, claimant’s written statement does not show how an illness in August 2021 prevented claimant from filing her application for review by March 11, 2021. Claimant also asserts in her written statement that she did not have internet. EAB Exhibit 1 at 3. Even if claimant did not have internet during the entire twenty-day appeal period, claimant’s statement does not show that a lack of internet would prevent a timely application for review because an application for review may be filed by mail. For these reasons, claimant’s written statement did not describe circumstances that prevented claimant from filing the application for review on time. Accordingly, claimant did not show good cause for the late application for review, and claimant’s late application for review is dismissed.

DECISION: The application for review filed December 3, 2021 is dismissed. Order No. 21-UI-161280 remains undisturbed.
